(iii) Qualifications and experience of the proposed team which Brief Description: Plumtree is a small but rapidly expanding town. This growth has seen high demand in accommodation. This demand in housing has caused urban sprawl and consequently put a strain on the existing infrastructure. The most affected being water and sewer reticulation and their associated infrastructure.

Plumtree Town Council wishes to engage the services of competent and registered Civil engineering consulting firms with adequate experience in water and waste water infrastructure designs and evaluation. The projects involve evaluation of existing water and sewer infrastructure in Plumtree town council.

The projects are necessitated by the rapid growth of the Town. Consultancy work will involve evaluation of existing water and sewer infrastructure for Mathendele Suburb, Plumtree Brooke and the water treatment plant capacity assessment.

- 3. (1) Copy must appear on one side only of each sheet of paper.
- (2) Except as is provided in subsection (2) of section 8, paper must not exceed 210 millimetres in width.
- (3) If copy comprises two or more sheets of paper, all sheets must be numbered consecutively, in arabic figures, preferably in the top right-hand corner.
- (4) Where any matter is added after the copy has been prepared, and such additional matter results in one or more sheets being inserted between those already numbered, all sheets must be renumbered from there onwards—not, for instance 7, 7b,
- Photographic copy or copy produced on a duplicating machine may be accepted if it is abundantly clear.
  - - (a) exceed 10 pages of double-spaced typing on size A4 paper; or
    - contain tabular or other matter which involves complicated setting; it will be classed as "lengthy' copy, and will be required to be submitted not less than 21 days before the date of closing for the Gazette in which it is to be published.
- (2) Lengthy copy may be accepted at less than 21 days' notice if-
  - (a) the work involved is of a straight forward and non-tabular
  - (b) the total volume of work on hand for the time being permits its acceptance.

- Copy for all advertisements, whether sent by post or delivered by hand, must be accompanied by a requisition or a letter which clearly sets out-

  - (3) For the removal of doubt—
  - (a) a typographical error is made by a typographer;
  - (b) a typist's error is classed as a drafting error by reason of the fact that the officer responsible for drafting failed to check the typist's work.

# Banking (Amendments) Regulations, 2020 (No. 4)

IT is hereby notified that the Minister of Finance and Economic Development has, in terms of section 81 of the Banking Act [Chapter 24:20\and in consultation with the Reserve BankofZimbabwe as required by subsection (5) of that section, made the following regulations:—

- 1. These regulations may be cited as the Banking (Amendment) Regulations 2020 (No. 4).
- 2. Section 3 of the Banking Regulations, 2000, published in Statutory Instrument 205 of 2000 (hereinafter referred to as the principal regulations), is amended by the deletion of "two thousand dollars" and the substitution of "fifty thousand dollars".
- 3. Section 6(1) of the principal regulations is amended by the deletion of "one hundred thousand dollars" and the substitution of "two thousand dollars".
- 4. Section 7(lb) of the principal regulations is deleted and substituted with the following—
  - "(lb) The maximum annual fee payable by a registered banking institution shall be ninety thousand dollars while the minimum annual fee payable by a registered banking institution shall be thirty thousand dollars."
- 5. Section 8(2) of the principal regulations is amended by the deletion of "one thousand dollars" and the substitution of "twenty thousand dollars".
- 6. Section 9(2) of the principal regulations is amended by the deletion of "one thousand dollars" and the substitution of "twenty thousand dollars".
- 7. Section 10 of the principal regulations is amended by the deletion of "five thousand dollars" and the substitution of "five thousand United States dollars".
- 8. Section 12 of the principal regulations is repealed and substituted with the following:

"Minimum equity capital of banking and other financial institutions

12. (1) In this section-

## Banking (Amendments) Regulations, 2020 (No. 4)

- "tier (i) banking institutions" means the large commercial banks that are permitted to conduct their core banking activities and other activities such as mortgage lending, leasing and hire purchase and other sophisticated products;";
- "tier (ii) banking institutions" means commercial banks, merchant banks, building societies, development banks, finance houses and discount houses that are limited to conduct their core banking services;".
- (2) For the purposes of section 29 of the Act the minimum capital for banking institutions shall be as follows
  - (a) an amount in local currency, equivalent to thirty million United States dollars for tier (i) banking institutions; and
  - (b) an amount, in local currency, equivalent to twenty million United States dollars for tier (ii) banking institutions.".
- 9. Any banking institution conducting its banking business at the time of coming into operation of these regulations shall have up until 31 st December, 2020, to comply with the minimum capital levels prescribed under this section.
- 10. Section 13 of the principal regulations is amended in subsection (1) by the deletion of "ten*per centum*" and the substitution of "thirty*per centum*".
- 11. Paragraphs 4 and 5 of the Third Schedule of the principal regulations are deleted and substituted by the following—

#### Minimum core risk-based capital ratio

 The minimum core risk-based capital ratio for a banking institution shall be eight per centum.

#### Minimum total risk-based capital ratio

5. The minimum total risk-based capital ratio for a banking institution shall be twelve *per centum*".

IT is hereby notified that the Minister of Local Government and Public Works has, in terms of section 229 of the Urban Councils Act *[Chapter 29:15]*, approved the following by-laws made by Epworth Local Board: —

#### Title

1. These by-laws may be cited as the Epworth (Hawkers and Vendors) By-laws, 2020.

# Application

2. These by-laws shall apply to the area under the jurisdiction of the Epworth Local Board.

## Interpretation

- 3. In these by-laws
  - "authorised person" means any person employed or delegated by the council to carry out any function in terms of these by-laws;
  - "Board" means the Epworth Local Board, acting through or by its duly authorised officer or those acting on their behalf;
  - "contagious and infectious disease" means
    - (a) any disease specified in or declared in terms of the Public Health Act [Chapter 15:09] as an infectious disease; or
    - (b) any venereal disease or contagious skin disease;
  - "environmental health practitioner" means a person registered in a profession or calling specified in Part VII of the First Schedule of the Health Professions Act [Chapter 27:19], and appointed by the Board;
  - "food" has the meaning given to it in terms of the Food and Food Standards Act [Chapter 15:04];
  - "goods" means wares merchandise produce and in general, corporeal, movable things of any description;

#### S.I. 138 of 2020

- "hawker" means any person who carries on the business of selling goods whilst travelling about for that purpose from place to place with the goods, either on foot or with vehicle, animal or carrier, but does not include—
  - a baker or his or her employee in respect of the sale of bread;
  - (b) a dairy marketing, or a dairyman or its or his or her employee, as the case may be, in respect of the sale of milk;
  - (c) any person in respect of the sale of publications sponsored by the State or newspapers;
- "health inspector" means a health inspector registered by the Medical Council of Zimbabwe and appointed by the Board;
- "licence" means a licence issued in terms of section 6 of these by-laws;
- "medical officer" means the medical officer registered by the Medical Council of Zimbabwe and appointed by the Board;
- "People's Market" means any premises set aside by the Epworth Local Board for the purpose of providing a place for sale of any good or food stuffs;
- "permit" means any document issued on behalf of the Board by a designated officer permitting the use of a stall, table or stand at a People's Market;
- "prescribed fee" means the fees fixed in terms of section 20 of these by-laws;
- "public place" means any bridge, enclosure, footpath, garden open space, pavement, road, sanitary lane sidewalk, square, subway or street of the nature of a thoroughfare vested in or controlled by the Board, and to which the public or any section of the public has access;
- "sell" includes barter, exchange, offer to dispose of or prepare for sale:
- "stall or table" means any surface constructed above ground level, or similar structure, whether or not it is situated within a building or under a roof or other structure;

- "stand" has the meaning given to it in terms of the Land Survey Act [Chapter 20:12]
- "vendor" means any person who sales goods from one or more fixed places in a private or public place, and any person who carries on the business of selling goods in or within a flea market premise, but does not include the sale of publications sponsored by the State or newspapers.

# Control of hawkers and street vendors

- 4. (1) No person shall, whether as principal or agent, carry on the business of a hawker or street vendor—
  - (a) unless he or she is the holder of a hawker's or street vendor's licence or he or she is engaged or employed by the holder of the hawker's or street vendor's employer's licence;
  - (b) if he or she sells food, unless he or she is the holder of a valid health certificate;
  - (c) subject to the provisions of subsection (2), in any area specified in the First Schedule.
- (2) The Board may by notice, subject to the conditions or restrictions imposed on the licence, authorise hawkers and vendors to carry on their business in such places or stands on such days and during such hours and in respect of such goods as may be specified in the notice.

# Control of employers of hawkers and vendors

- No person shall engage or employ another as an agent hawker or vendor—
  - (a) unless
    - (i) the first mentioned person is the holder of a hawkers' employer's licence or a vendors' employer's licence as the case may be; or
    - (ii) the hawker or vendor concerned is the holder of a hawker or vendor's licence, as the case may be;
  - (b) for the sale of food, unless the hawker or the vendor concerned is the holder of a valid health certificate.

#### S.I. 138 of 2020

# Application for hawker's or vendor's licence

- 6. An application for a hawker's licence, a vendor's licence or both made to the Board shall be—
  - (a) accompanied by the prescribed fee;
  - (b) in the form prescribed in the Second Schedule;
  - accompanied by two recent identical full-face portrait photographs of the applicant without head-gear which must be driver's licence size; and
  - (d) in the case of an applicant who wishes to sell food, a health certificate.

# Application of hawkers' or vendors' employer's licence

- 7. An application for a hawkers' employer's licence or a vendors' employer's licence made to the Board shall be
  - (a) accompanied by the appropriate fee;
  - (b) in the form prescribed in the Second Schedule.

# Applicants to permit inspection

- 8. Any person who is an applicant in terms of section 6 or 7 shall, at the request of a health inspector or any person specifically authorised thereto by the Board—
  - (a) produce for inspection at the offices of the Board any vehicle, container, clothing or equipment to be used in connection with the business for which a licence is required; and
  - (b) permit such health inspector or person to inspect any vehicle, container, storage premises, site, clothing or equipment which is to be used in connection with the business for which the licence is required.

# Restrictions and conditions of licence

- 9. (1) The Board may, in issuing or renewing a licence
  - (a) restrict the applicant to dealing in goods listed in his or her application;

- (b) restrict the applicant to dealing in certain goods, whether listed in his or her application or not, if, in its opinion, not to make such restriction would—
  - (i) adversely affect any existing trade or business carried on in the area of jurisdiction of the Board; or
  - (ii) be undesirable in the interests of public health, public safety or public morality or public order;
- (c) restrict the applicant to carry on the business for which the licence is required to certain areas and sites and on certain hours and days;
- require the applicant to affix to any vehicle, container or stall used in connection with the business for which the licence is required such identification marks as the Board may specify;
- (e) require the applicant, in the case of a hawkers 'employer's or vendors' employer's licence to ensure that his or her agents or employees whilst engaged upon the business for which the licence is required, wear such clothing and display, in such manner as to be clearly visible, such badges for the purposes of identifying them with the applicant as the applicant may specify;
- (f) require the applicant in the case of a hawker's licence or vendor's licence, whilst engaged in the business for which the licence is required, to wear such clothing and to display, in such manner as to be clearly visible, such badges as the Board may specify.
- (2) Any condition or restriction imposed by the Board in terms of subsection (1) shall be specified on the licence concerned.
  - (3) Any person who—
  - (i) operates without a vendors or hawkers licence; or
  - (ii) operates with an expired or false licence.

shall be guilty of an offence and liable to a fine not exceeding level 6 or to imprisonment for a period of three months or to both such fine and such imprisonment.

# Currency, renewal and variation of licence

- 10. (1) A licence issued or renewed in terms of these by-laws shall be in the form set out in the Third Schedule, and shall be valid up to and including the 31st December, of the year in which it was issued or renewed.
- (2) The holder of a licence who wishes to renew the licence for the next succeeding year shall apply to the Board for the renewal thereof during the month of December preceding that year, and the provisions for sections 6 and 7 shall, *mutatis mutandis*, apply:

# Provided that the Board may—

- (a) waive the requirement to submit any photograph with an application for the renewal of a licence;
- (b) require the production of the licence previously issued to him or her.
- (3) The holder of a licence who wishes to have any condition or restriction imposed upon his or her licence altered or removed, either during the period of its validity or renewal, shall—
  - (a) in the case of a renewal, specify the nature and extent of the variation required in his or her application for renewal;
  - (b) in any other case, make application, in writing, to the Board, specifying the nature and extent of the variation required.
- (4) When an application made in terms of subsection (3)(b) is successful, the applicant shall submit his or her licence to the Board for the appropriate endorsement to be made.

# Refusal of application or renewal of licence

- 11. The Board may refuse to issue or renew a licence if—
  - (a) the applicant has, within two years, preceding the making of the relevant application, been convicted of—
    - (i) any offence under these by-laws which were repealed on adoption of these by-laws; or
    - (ii) any offence under the Trade Measures Act [Chapter 14:23]; or

- (iii) any offence which involves carelessness concerning, or a disregard for cleanliness, hygiene, public health or public nuisance; or
- (iv) any offence involving dishonesty; and has been sentenced therefore to imprisonment without the option of a fine whether or not the sentence has been suspended; or
- (b) in the opinion of the Board—
  - the issue of renewal would adversely affect any existing trade or business carried on in the area of jurisdiction of the Board; or
  - (ii) the goods sought to be dealt in ought not to be dealt in the interests of the public health, public safety or public morality; or
  - (iii) any vehicle, container, stall, storage-premises, clothing or equipment used, for or to be used in connection with the business for which the licence is unsuitable in the interests of public health.

# Replacement of lost or destroyed licence or badge

- 12. Any person who has been issued with a licence or badge in terms of these by-laws may obtain a duplicate thereof—
  - (a) after certifying the Board, in writing, that the licence or badge concerned has been lost or destroyed; and
  - (b) on payment of the appropriate fee.

# Change of address or abandonment of business

13. A holder of a licence shall, within seven days ofthe abandonment of his or her business or of any change of address of his or her business or his or her storage-premises, notify the Board in writing of such fact or of such change of address as the case may be.

# Cancellation of licence

- 14. (1) The Board may cancel a licence if the holder thereof at any time after the issue of the licence—
  - (a) has been convicted of any offence referred to in section 11(a); or

- (b) does not maintain a satisfactory standard of cleanliness in respect of his or her person or any agent of his or hers who is engaged or employed in the business to which the licence relates; or
- (c) does not maintain a satisfactory standard of cleanliness in respect of any vehicle, container, stall, storage premises, clothing or equipment used by him or her or by any agent of his or hers in connection with the business to which the licence relates
- (2) The Board shall cancel a hawker's licence or vendor's licence if the holder thereof is dealing in food and is found to be suffering from a contagious and infectious disease:

Provided that the Board shall, at no extra charge, reissue the holder with a licence if—

- (a) he or she produces a health certificate, issued after the date of cancellation of the licence, certifying that he or she is no longer suffering from a contagious and infectious disease: or
- (b) he or she applies to the Board for his or her licence to be restricted and sale of goods other than food and submits his or her licence to the Board for the purpose of the relevant endorsement to be made.
- (3) Any licence cancelled in terms of this section shall be returned to the Board by the holder thereof within thirty days of such cancellation.

# Inspection of vehicles, stalls, storage and premises

- 15. (1) A health inspector or any authorised person may at any reasonable time inspect any vehicle, container, stalls, storage premises, clothing or equipment used by the holder of a licence or a hawker or vendor engaged or employed by the holder of the licence in connection with the business to which the licence relates, in order to ascertain whether—
  - (a) a clean and sanitary condition is being maintained; or
  - (b) the provisions of these by-laws are being complied with.

- (2) No person shall hinder, obstruct or prevent a health inspector or person authorised in terms of subsection (1) from making an inspection in terms of that subsection.
- (3) Any person who hinders, obstructs or prevents a health inspector or person authorised in terms of subsection (1) from making an inspection shall be guilty of an offence and liable to a fine not exceeding level 3 or to imprisonment for a period of fifteen days or to both such fine and such imprisonment.

# Health, cleanliness and food

- 16. (1) No holder of a licence or hawker or vendor engaged or employed by the holder of a licence shall allow or permit any vehicle, container, stall, storage premises, clothing or equipment used in connection with the business to which the licence relates to be in a dirty or insanitary condition.
- (2) No holder of a licence or hawker or vendor engaged or employed by the holder of a licence shall sell or allow to be sold, any food which is not in a sound or wholesome condition.
  - (3) No hawker or vendor shall sell any food—
  - (a) unless he or she has taken adequate precautions to safeguard the food from dirt, dust, flies or other contamination;
  - (b) whilst to his or her knowledge, he or she is suffering from any contagious and infectious disease.
- (4) No holder of a licence, hawker or vendor engaged or employed by the holder of a licence shall use any vehicle, container, stall, storage-premises, clothing or equipment used for transporting or storing food for any other purpose.
- (5) Any person who contravenes the provisions of subsections (1) to (4) shall be guilty of an offence and liable to a fine not exceeding level 3 or to imprisonment for a period of fifteen days or to both such fine and such imprisonment.

# Removal of litter

17. A hawker or vendor shall—

#### S.I. 138 of 2020

- (a) pick up any litter which in the exercise of his or her business has fallen on any public place;
- (b) on request by any official to the Board, move his or her receptacles and goods so as to permit such official to clean the streets or gutters;
- (c) remove all receptacles and goods from his or her place or stand on the completion of business for the day and shall leave his or her place or stand in a clean condition.

#### Obstruction or nuisance

- 18. (1) Any authorised person may direct any hawker or vendor who is directly or indirectly obstructing the use of any public place, or is a nuisance to any person in the vicinity of any public place, to move for such distance as may be reasonable or to cease such obstruction or to abate such nuisance, as the case may be.
- (2) No hawker or vendor shall refuse to comply with any direction given in terms of subsection (1).

# Impounded goods

- 19. (1) Any authorised person or environmental health practitioner or municipal police shall impound goods of any hawker or vendor suspected of violating the provisions of section 4 and section 5 of these by-laws.
- (2) If the impounded goods are perishable, the goods shall be disposed of in the presence of municipal police and health inspector within 24 hours in terms of laid down disposal conditions set in accordance with the requirements of the Public Health Act [Chapter 15:09], when the person is subsequently found guilty in terms of subsection (1) above.
- (3) If the impounded goods are perishable, the goods shall be disposed of in the presence of municipal period not exceeding 30 days and when the person is subsequently found guilty in terms of subsection (1) above the goods shall be auctioned at a public auction at the expiry of the 30 days period and the proceeds from the auction shall accrue to the Board.

(4) If the goods are impounded in terms of subsection (2) and (3) above, the Board shall cause a Disposal or Auction Form to be completed and witnessed by one municipal police man and one health inspector see Fourth Schedule attached.

#### Fees

20. (1) The Board may, by resolution, fix fees for any application made in terms of these by-laws and for any licence, certificate or badge, or duplicate thereof, issued in terms of these by-laws:

#### Provided that—

- (a) any fee shall be fixed through a Board resolution; and
- (b) the fee for a licence issued after the 30th of June in any year shall be fifty *per centum* of the annual fee for such licence.
- (2) All fees passed by the Board shall be published in the Government *Gazette* and displayed at the respective offices.

## Labour (Domestic Workers) Employment (Amendment) Regulations, 2020 (No. 20)

IT is hereby notified that the Minister of Public Service, Labour and Social Welfare, in terms of section 17 of the Labour Act [Chapter 28:01], has made the following regulations:—

#### Title

- 1. These regulations may be cited as the Labour (Domestic Workers) Employment (Amendment) Regulations, 2020 (No. 20).
- 2. With effect from the date of the publication of these regulations, the Lirst Schedule and the Second Schedule to the Labour (Domestic Workers) Employment Regulations, 1992, published in Statutory Instrument377 of 1992 (hereinafter called "the principal regulations"), are amended as follows —

1. Statutory Instrument 210 of 2019, is hereby amended by the deletion of the whole section 1 and substitution with the following—

### "Salaries and wages

(a)

- (i) housing allowance for employees in urban zones increases from RTGS\$70,00 to RTGS\$150,00, per month;
- (ii) housing allowance for employees in areas with ginneries increases from RTGS \$45,00, to RTGS\$92,00, per month;

(b)

- (i) transport allowance for employees in Harare increases from RTGS\$85,00, to RTGS\$170,00, per month.
- (ii) transport allowance for all other employees in urban areas per graded zones increases from RTGS\$40,00, to RTGS\$80,00, per month;
- (c) wages and salaries shall be the same for permanent, long term, short-term contract and seasonal employees. The harmonized salaries increase by 78,5% across the board;
- (d) the minimum salary/wage applicable to all employees shall be RTGS\$600,00, for Grade A1 employees;
- (e) monthly ginning shift allowance increases from RTGS\$30,00, to RTGS\$60,00.
