Customs and Excise (Printing and Packaging) (Rebate)
(Amendment) Regulations, 2024 (No. 9)

IT is hereby notified that the Minister of Finance, Economic Development and Investment Promotion, in terms of section 235 as read with section 120 of the Customs and Excise Act [*Chapter 23:02*], hereby makes the following regulations:—

1. These regulations may be cited as the Customs and Excise (Printing and Packaging) (Rebate) (Amendment) Regulations, 2024 (No. 9).

2. The Customs and Excise (Printing and Packaging) (Rebate) Regulations, 2016, published in Statutory Instrument 152 of 2015, are amended in the Third Schedule by addition of the following manufacturers—

Customs and Excise (Suspension) (Amendment)
Regulations, 2024 (No. 276)

IT is hereby notified that the Minister of Finance, Economic Development and Investment Promotion has, in terms of section 235, as read with section 120 of the Customs and Excise Act [Chapter 23:02], made the following regulations:—

1. These regulations may be cited as the Customs and Excise (Suspension) (Amendment) Regulations, 2024 (No. 276).

2. The Customs and Excise (Suspension) Regulations, 2003, published in Statutory Instrument 257 of 2003 (hereinafter called “the principal regulations”), are amended by the deletion of the Schedule and the substitution of the following—
