INCOME TAX ACT [CHAPTER 181]

Public Notice to Furnish Returns for the Year of Assessment Ended on the 31st March, 1981

NOTICE is hereby given that all persons falling within the classifications set out below, and all persons to whom forms have been sent, are required to furnish returns for assessment within 30 days after the date of publication of this notice.

Returns are required from:

- Every person whose income for the year ended on the 31st March, 1981, exceeded \$2 400, and who—
 - (a) had his wife living with him or wholly maintained her during any part of that period, and was not separated by judicial order or written agreement; or

- (b) had the custody of, and maintained during more than half of the period, an unmarried, lawful child of his own who was born on or after the 1st April,
- Note.—The income of a woman married with or without community of property, and not separated from her husband under a judicial order or written agreement, and not living apart from her husband and wholly maintaining herself, is deemed to be income of her husband for the purposes of the Income Tax Act [Chapter 181], and must be included by him in his returns of income required to be rendered by him under the Act.
- 2. Every person (other than a company) who does not fall within the terms of paragraph 1 and whose income for the year ended on the 31st March, 1981, exceeded \$1 500.
- The representative taxpayer, as defined in section 42 of the Income Tax Act [Chapter 181], of—
 - (a) every company or trust;
 - every person falling within the terms of paragraphs 1 and 2 who—
 - (i) is permanently or temporarily absent from Zimbabwe;
 - (ii) is a minor;
 - (iii) is mentally disordered or defective or is under legal disability;
 - (iv) receives income under the decree of any court or judge through a receiver or other person;
 - (v) died during the year ended on the 31st March, 1981, or who died after the 31st March, 1981, before rendering a return of income for the year ended on the 31st March, 1981.
- 4. Every person, whether liable to taxation or not, to whom a form has been sent.

Conditions for Acceptance of Copy

FAILURE to comply with any of the following conditions will result in the rejection of copy, and no responsibility can be accepted if such rejection should affect any date contained in such copy or any requirement of publication on a specific date.

Persons drafting any kind of notices are strongly advised to follow the guidance offered in—

- (a) the Instructions Relating to the Drafting and Typing of Legislation (Attorney-General's Circular 1 of 1978); and
- (b) the Manual of Style for the Drafting and Preparation of Copy, published by the Department of Printing and Stationery;

which two booklets are intended for complemental use.

In these conditions, other than where a particular kind of copy is specified, "copy" means copy for all matter contained in the Gazette itself and for subsidiary legislation issued as supplements to the Gazette.

- 1. (1) Other than by prior arrangement, only original typing is accepted.
- (2) Carbon-copies are not normally acceptable, other than in cases where the original typing has to be legally retained elsewhere, as, for example, in the case of a proclamation.
- (3) Computer print-outs are not accepted automatically, as discussion may be necessary with regard to the extra time and costs involved.
- 2. (1) All copy must be clear and legible, and there must be double or one and a half spacing between the lines.
- (2) Any corrections or alterations made by the originator must be clearly effected in blue or black ink, using editorial marks—not proof-reader's marks:

Provided that any copy containing extensive alterations will be rejected.

- 3. (1) Copy must appear on one side only of each sheet of paper.
- (2) Except as is provided in subsection (2) of section 8, paper must not exceed 210 millimetres in width.
- (3) If copy comprises two or more sheets of paper, all sheets must be numbered consecutively, in arabic figures, preferably in the top right-hand corner.
- (4) Where any matter is added after the copy has been prepared, and such additional matter results in one or more sheets being inserted between those already numbered, all

sheets must be renumbered from there onwards—not, for instance, 7, 7a, 7b, 8, et cetera.

4. Photographic copy or copy produced on a duplicating-machine may be accepted if it is abundantly clear.

5. (1) Should any copy-

(a) exceed 10 pages of typing on A4 paper; or

(b) contain tabular or other matter which involves complicated setting;

it will be classed as "lengthy" copy, and will be required to be submitted not less than 21 days before the date of closing for the Gazette in which it is to be published.

(2) Lengthy copy may be accepted at less than 21 days' notice if—

(a) the work involved is of a straight-forward and nontabular nature; and

the total volume of work on hand for the time

being permits its acceptance.

6. Notwithstanding anything to the contrary contained in these conditions, any copy-
