If, in the opinion of the Minister of Finance, the prize-fund is insufficient for the purpose, the amounts of the first three prizes listed above shall be reduced as directed by that Minister.

(iii) Two introducers' jackpot prizes: prize, \$50; introducer, \$500

Only full dollar tickets issued against one written order for 14 full tickets in one unit are eligible to win these prizes, provided that such written order has been compiled at one and the same time. Prizes not won will be carried forward and used to increase the jackpot prizes in the following unit. These prizes will be drawn after the draw for ordinary prizes has been

completed. (Quarter-tickets without counterfoils are excluded.)

3. Double and treble prizes

which two booklets are intended for complemental use.

In these conditions, other than where a particular kind of copy is specified, "copy" means copy for all matter contained in the Gazette itself and for subsidiary legislation issued as supplements to the Gazette.

- 1. (1) Other than by prior arrangement, only original typing is accepted.
