## INCOME TAX ACT [CHAPTER 181] FISCAL APPEAL COURT ACT [CHAPTER 180]

Appointment of President of Special Court and Fiscal Appeal Court.

Copyright (Government Maps, Aerial Photographs, Plans and Charts) Notice, 1984

IT is hereby notified, for public information, that the fol-lowing provisions apply in respect of the reproduction of maps, aerial photographs, plans and charts copyright in which subsists in the Government of Zimbabwe.

1. This notice may be cited as the Copyright (Government Maps, Aerial Photographs, Plans and Charts) Notice, 1984.

Government copyright

- 2. By virtue of section 49 of the Copyright Act, [Chapter 200], and the rights assigned to Government by the Liquidating Agency constituted by the Federation of Rhodesia and Nyasaland (Dissolution) Order in Council, 1963, copyright vests in the President in all maps aerial photographs, plans vests in the President in all maps, aerial photographs, plans and charts
  - produced or published by the Surveyor-General prior to the assignment of the copyright in such maps, aerial photographs plans and charts to the Government of the former Federation of Rhodesia and Nyasaland, for the unexpired period of 50 years from the end of the calendar year in which the map, aerial photograph, plan or chart was made: or chart was made;
  - depicting Zimbabwe, either wholly or in part, prepared or published by the Director of Trigonometrical and Topographical Surveys of the former Government of the Federation of Rhodesia and Nyasaland, for the unexpired period of 50 years from the end of the calendar year in which the map, aerial photograph, plan or chart was made;
  - produced or published by the Surveyor-General after the 1st January, 1964, for a period of 50 years from the end of the calendar year in which the map, aerial photograph, plan or chart was made.

Infringement of copyright

5. Subject to the provisions of this notice, Government copyright will be deemed to have been infringed by any person who, without the written consent of the Surveyor-General, reproduces or stores in a retrieval system or transmits in any form or by any many whether electronic mechanical photofeproduces or stores in a retrieval system or transmits in any form or by any means, whether electronic, mechanical photo copying, recording or otherwise, or translates into another language any copy of or from any map, aerial photograph, plan or chart referred to in section 2 of this notice, whether the copying is direct or through a fresh drawing, in whole or in part, or from any map or document based on such map, aerial photograph, plan or chart.

# Permission to reproduce maps, aerial photographs,

- 4. (1) Subject to the provisions of subsection (6), any person wishing to reproduce any map, aerial photograph, plan or chart referred to in section 2 of this section or any portion thereof shall make application, in writing, to the Surveyor-General, who may grant, in writing, or refuse permission for such reproduction to be made.
- (2) If permission is granted in terms of subsection (1), the Surveyor-General will notify the applicant that such permission has been granted and reproduction may not be put in hand until such time as the letter conveying such permission has been received by the applicant.
- (3) Permission, if granted in terms of subsection (1), shall be subject to such conditions as the Surveyor-General may impose and these conditions shall be set out in the letter conveying the permission.
- (4) Permission will not normally be granted where a reproduction is to be made for any purpose for which the maps, aerial photographs, plans or charts referred to in section 2 of this notice are suitable.
- (5) Permission granted in terms of subsection (1) for the reproduction of any map, aerial photograph, plan or chart shall specify the form, quantity and limits permitted, and if any person wishes to reprint any reproduction, a further application therefore shall be made.
- (6) It shall not be necessary for any person to obtain permission to reproduce a map, aerial photograph, plan or chart referred to in section 2 of this notice or any portion thereof where reproduction will be at a scale of 1:3000000
- (7) In the event of the Surveyor-General entering into an agreement with a person or company, concerning the joint copyright of maps, aerial photographs, plans and charts, it will be necessary for the applicant to seek permission from both parties in order to reproduce any maps, aerial photographs, plans or charts of the joint copyright agreement.

# Acknowledgement

- 5. (1) Subject to the provisions of subsection (2), every authorized reproduction shall bear an acknowledgement in the form "Reproduced with the permission of the Surveyor-General of Zimbabwe. Copyright reserved".
- (2) Departures from the form of acknowledgement set out in subsection (1) shall only be by written permission of the Surveyor-General.

#### Royalties

- 6. (1) Permission to reproduce any map, aerial photograph, plan or chart referred to in section 2 of this notice will normally be subject to the payment of a royalty fee which will be assessed in accordance with the scale of royalties specified in Part I of the Schedule to this notice, taking into account the category of copying as defined in section 7, the number of copies required and the area of the document to be copied.
- (2) Royalties will not normally be charged for the use of material in any map, aerial photograph, plan or chart referred to in section 2 of this notice where such map, aerial photograph, plan or chart is at a scale of 1:300 000 or smaller, and where the material is to be used for the compilation or revision of a publication which is to be redrawn.
- (3) Royalties will not normally be charged in respect of facsimile reproductions of extracts of maps, aerial photographs, plans or charts referred to in section 2 of this notice
  - the total area of the extract or extracts to be reproduced from a single map, aerial photograph, plan or chart in any one publication shall not exceed 0,1 square metre;
  - the extract or extracts form part of a guide book or travel brochure, which is to be issued free to the public;
  - the extract or extracts form part of a textbook, thesis, professional paper or similar publication;

- (4) In the event of subsection (7) of section 4, royalties will be charged in accordance with the scale of royalties specified in Part I of the Schedule, and will be proportioned between the joint copyright holders as determined by the Surveyor-
- (5) Royalties for the reproduction of material in newspapers, as defined in the Printed Publications Act [Chapter 88], the retail selling price of which in the country of publication is 25 cents or less, or the equivalent in local currency, shall be calculated at the rate of one-tenth of the amount payable in terms of Part I of the Schedute.

Categories of copying

- 7. (1) There shall be three categories of copying which will attract the rates of royalty fees specified in Part I of the Schedule to this notice.
- (2) The three categories of copying referred to in subsection (1) will apply as follows—
  - (a) Category A—copying of publications which have been directly reproduced from material from the Department of the Surveyor-General, with limited changes, but without redrawing or generalising.
  - (b) Category B—copying of publications which have been compiled from material from the Department of the Surveyor-General, but completely redrawn to the publishers own specifications.
  - Category C—copying of publications where published or unpublished materials from the Department of the Surveyor-General are used for revision purposes only.

#### Licence to reproduce maps, aerial photographs, plans or charts for personal use

8. Any local authority, statutory body or civil engineering firm in Zimbabwe wishing to make copies of any map, aerial photograph, plan or chart referred to in section 2 of this notice for the purpose of its normal day-to-day functions, and which are not for publication, may apply to the Surveyor-General for a licence to copy such map, aerial photograph, plan or chart on payment of the annual sum specified in Part II of the Schedule to this notice, such licence to expire at the end of the calendar year in respect of which it is issued.

#### Agreements on street guides

9. Nothing in this notice skall prevent the Surveyor-General from entering into agreements with firms for the producing of street guides or maps where royalties may be dispensed with in return for receiving reproduction material.
