## INLAND WATERS SHIPPING ACT [CHAPTER 258]

## Notice to Mariners (No 1 of 1986)

IT is hereby notified that, in terms of subsection (1) of section 141 of the Inland Waters Shipping Regulations, 1971, the following instructions are issued to mariners—

*Inland Waters: Petrol in fuel tanks of motor-vehicle transported in motor-vessels and ferries*

1. No motor-vehicle which is transported on or under deck shall have its tank so full as to create a possibility of spillage.
2. The ignition of a motor-vehicle which is transported on or under deck shall be switched off.

3. To guard against the possibility of accidents occurring due to spillage of petrol from a motor-vehicle transported in a motor-vessel or ferry, the following precautions shall be taken—

- (a) spot checks shall be carried out before a motor-vehicle is loaded on the motor-vessel or ferry to ensure that the tank of such motor-vehicle is not so full as to create a possibility of spillage (attention of the owner or person in charge of the motor-vehicle shall be drawn to paragraphs 1 and 2 above, at the time of booking or issue of tickets or prior to the loading of the vehicle, whichever comes first);
- (b) passengers shall not be allowed access to the deck of a motor-vessel or ferry when it is under way, except—
  - (i) on a ferry where the motor-vehicle is loaded on open deck; or
  - (ii) under special circumstances where the passenger has to be accompanied by a member of the crew; or
  - (iii) where special arrangements have been made prior to the journey for invalids who are unable to walk;
- (c) conspicuous "No Smoking" notices shall be exhibited together with notices warning against engines being started before doors leading to rooms are opened and members of the crew shall be stationed to instruct passengers accordingly;
- (d) a fire patrol shall be maintained on the deck of a motor-vessel or ferry during the voyage;
- (e) any spillage of petrol shall be cleaned up without delay; buckets of sand, drip trays and mopping up equipment shall be provided for use on the deck of every motor-vessel or ferry;
- (f) the crew of a motor-vessel or ferry which transport motor-vehicles shall be well trained in fire-drill;
- (g) the number of air changes may be increased when a motor-vehicle is being loaded into or unloaded from a motor-vessel or ferry to ensure that any concentration of inflammable vapours or noxious fumes does not become a health or fire hazard.

One Hundred and Seventy-sixth State Lottery: Units Two, Three and Four

NOTICE is hereby given, for general information, that units two, three and four of the one hundred and seventy-sixth State lottery will be drawn in public under the direction of the Minister of Finance, Economic Planning and Development at the venues stated below:

Unit two—10th October, 1986—12.30 p.m., State Lottery Hall, Harare.

The first prize will be \$50 000 in all units.

*Conditions for each unit*

1. Based on the face value of all tickets sold or issued free, up to 25 per cent. of the total subscriptions may be reserved for social service, public welfare or relief of distress.

## 2. Prizes

The prize fund will be distributed as follows—

(i) Ordinary prizes: Units two, three and four—  
First—as above; Second—\$15 000; Third—\$7 500.  
Introducers—\$1 000; \$500; \$250.

(ii) The remainder of the prize-money will be distributed in smaller ordinary introducers', introducers' jackpot and consolation prizes. If in the opinion of the Minister of Finance, the prize fund is insufficient for the purpose, the amounts of the first three prizes listed above will be reduced as directed by the Minister.

(iii) Two introducers' jackpot prizes: Prize \$50; introducer: \$500

Only tickets issued against one written order for 14 tickets in one unit are eligible to win these prizes, provided such written order has been compiled at one and the same time. Prizes not won will be carried forward and used to increase the jackpot prizes in the following unit. These prizes will be drawn after the draw for ordinary prizes has been completed.

## 3. Double and treble prizes

Any lottery prize of \$200 or less won by a lottery ticket will be (i) *doubled* if the prize-winner sends in with his prize ticket, three additional lottery tickets in the same unit, or (ii) *trebled* if the prize-winner sends in with his prize ticket, seven additional lottery tickets in the same unit, provided that in order to qualify for the double and treble prizes, the counterfoils of all tickets submitted must have exactly the same name and address as that found on the counterfoil of the prize-winning ticket. (Nearly the same is not sufficient.) To give examples of

possible differences in the counterfoils—"J. Jones," "John Jones" and "Mr. J. Jones"; "Bvo." and "Bulawayo"; "Rd." and "Road"; "Box" and "P.O. Box".

Multiple prizes do not apply to introducers' prizes and consolation prizes.

## 4. The draw

(a) The number of all tickets sold will participate in the draw for all prizes.

(b) If the Director is satisfied that a fault has occurred in the drawing of a prize number, a "no draw" shall be announced and the prize shall be drawn again. A ball jamming when coming out of a drum will not in itself be considered as a fault. Examples of faults—

(i) one or more balls appearing before control button is pressed;

(ii) control button pressed before all balls are in the drums.

(c) Subject to the provisions of the State Lotteries Act [Chapter 317], when a prize-number has been passed and recorded, no subsequent claim that a "no draw" should have been announced will be considered.

(d) Only one ordinary prize can be won by one ticket number. If a ticket is drawn, the prize is payable to the party whose name appears on the counterfoil. No trading in tickets will be recognized by the State Lotteries. If a number drawn represents an unsold ticket, a "no draw" will be announced and the prize will be drawn again. If the number drawn for a bigger prize represents a number of a ticket which has already won a smaller prize, the bigger prize will be payable. Except as provided by subparagraph (iii) of section 2 above, prizes will be drawn in order of value.

(e) Only the lucky names and towns of the purchasers of winning-tickets will be announced. Names are not announced or published.

## 5. Payment of prizes

(a) All cash prizes are free from taxation by the Government and are payable in full by cheque.

(b) Tickets are official receipts in themselves and prizes will be paid out on production of the winning-tickets. The Minister may authorize payment of a prize won by a lottery ticket without production of the ticket.

(c) If a syndicate wins a prize, it must nominate one or two members to whom the cheque is to be made payable on behalf of the syndicate.

## Conditions for Acceptance of Copy
