AGREEMENT BETWEEN ANZ p.l.c. FORMERLY GRINDLAYS BANK p.l.c. MEMORANDUM OF GRINDLAYS BANK

(Called "the Seller")

AND

ANZ GRINDLAYS BANK (ZIMBABWE) LIMITED (Called "the Purchaser")

# PREAMBLE

THE Seller is a company duly registered according to the laws of England and carries on business in England and elsewhere as a commercial bank. Further, the Seller has been

registered in Zimbabwe and has carried on business in Zimbabwe for many years as a commercial bank. The Seller has decided to transfer the banking business it carries on in Zimbabwe to a local company (the Purchaser), which it has registered and which is at present a wholly owned subsidiary of the Seller. In carrying on its banking business in Zimbabwe the Seller has obtained approval in terms of section 27 of the Banking Act [Chanter 1881] to hold shares section 27 of the Banking Act [Chapter 188], to hold shares section 27 of the Banking Act [Chapter 188], to hold shares in companies which do not carry on approved banking business, which shares it also wishes to sell and transfer to the Purchaser but its shareholding in ANZ Grindlays Finance (Zimbabwe) Limited will not be sold or transferred. The Seller and the Purchaser wish to record the agreement covering the sale and transfer of the said banking and other business to the Purchaser and the agreement is accordingly recorded bereunder. recorded hereunder.

# AGREEMENT CONDITIONAL

This agreement shall be conditional upon the happening of the following events by not later than the 1st day of

- 1.1 the receipt by the Seller of the written approval of this Agreement by the Minister of Finance, Economic Planning and Development of Zimbabwe in terms of section 17 of the Banking Act [Chapter 188] (called "the Banking Act");
- 1.2 the registration of the Purchaser as a commercial bank under the Banking Act; and
- 1.3 the appointment of the Purchaser as an authorized dealer under the Exchange Control Regulations, 1977, of Zimbabwe.

# 2. SALE OF BANKING BUSINESS

- 2.1 Subject to the fulfilment of the conditions afore said, and with effect from the 1st day of April, 1990, the Seller hereby sells to the Purchaser and the Purchaser hereby purchases the whole of the Seller's banking and other business as carried on in Zimbabwe at the 31st March, 1990, including all the liabilities and assets, corporeal and incorporeal, of every description appertaining to the business of the Seller in Zimbabwe (called "the said banking business"), all of which shall vest in the Purchaser from the 1st day of April, 1990.
- 2.2 For the removal of any doubt, it is recorded that the shares held by the Seller in those companies listed in the Schedule hereto annexed, do form part of the said banking business, but the shares held by the Seller in ANZ Grindlays Finance (Zimbabwe) Limited are not part of the assets hereby sold.

# 3. PURCHASE PRICE

- 3.1 The purchase-price of the said banking business shall be a sum equal to the net tangible asset worth thereof as determined by the Seller's auditors in Zimbabwe who shall determine the same as soon as possible after the 31st March, 1990.
- 3.2 The said purchase-price shall be payable to the The said purchase-price shall be payable to the Seller in cash but the Seller undertakes to utilize the said purchase-price to subscribe for 15 million shares of \$1 each in the capital of the Purchaser at a price equal to the price payable by the Purchaser to the Seller. The said price payable for the shares in the capital of the Purchaser shall be set-off against the amount due to the Seller by the Purchaser and the amount paid to the Purchaser in excess of the par value of the shares subscribed for, shall be credited to a share premium account in the books of account of the Purchaser. of account of the Purchaser.
- 3.3 As further consideration for the purchase of the said banking business, the Purchaser undertakes to be responsible for and to meet all liabilities due by the Seller at the close of business on the 31st March, 1990, in respect of the said banking business carried on by the Seller in Zimbabwe, which liabilities shall be determined by the said auditors afore said.

# 4. IMPLEMENTATION OF SALE

Without derogation from the generality of the provisions of clause 2 hereon, and with effect from the 1st day of

4.1 all agreements, appointments, nominations transall agreements, appointments, nominations trans-actions and documents made, entered into, drawn or executed by, with or in favour of the Seller in respect of or arising from the said banking business and in force immediately prior to the 1st day of April, 1990, shall remain of full force and effect and shall be construed for all purposes as if they had been made, entered into, drawn or executed by, with or in favour of the Purchaser;

4.2 any bond, pledge, guarantee or other instrument to secure advances, facilities or services, whether already made or provided, or to be made or provided, in respect of or arising from the said business shall remain of full force and effect, and shall be construed for all purposes as a bond, pledge, guarantee or instrument, as the case may be, given to or in favour of the Purchaser as security for such advances, facilities or services made or provided, or to be made or provided by the Purchaser;

4.3 any appointment or right held by the Seller immediately before the 1st day of April, 1990, whether alone or jointly with any other person as trustee, executor, administrator or in any other fiduciary capacity shall, on and after the 1st day of April, 1990, be held by the Purchaser, whether alone or jointly with such other person, in the same capacity upon the trusts and with and subject to the powers, provisions, liabilities and obligations applicable thereto respectively;

4.4 any reference to the Seller in any deed, instrument or other document, whether or not the Seller was a party thereto, and whether executed before, on or after the 1st day of April, 1990, relating to the said banking business or to acts, duties or obligations to be performed by the Seller shall, for the purpose of any act, matter or thing to be performed or to become operative on or after the 1st day of April, 1990, be deemed to be a reference to the Purchaser, which shall be entitled and obliged to recognize, honour or otherwise deal with all acts, duties and obligations to be performed thereunder as if reference to the Seller were a reference to the Purchaser; to the Seller were a reference to the Purchaser;

- 4.5 no action, arbitration or other proceedings, extra judicial or otherwise, then pending by or against the Seller in relation to the said banking business shall in any wise be prejudiced or affected by reason of this agreement, and the Purchaser shall be substituted as a party thereto in place of, and to the exclusion of the Seller;

The risk in all the assets comprising the said business shall pass to the Purchaser on the 1st day of April, 1990.

# APPOINTMENTS UNDER WILLS

Where before, on or after the 1st day of April, 1990, any person dies or has died domiciled in or out of Zimbabwe leaving property in Zimbabwe and leaving a will executed before, on or after the 1st day of April, 1990, which appoints or purports to appoint the Seller, whether alone or jointly with any other person or persons, to be the executor and/or administrator and/or trustee thereof, such will shall be construed and have effect as if any reference therein to the Seller was to the Purchaser. The Purchaser hereby indemnifies the Seller against all claims, losses or liabilities whatsoever and howsoever arising which the Seller may sustain or incur at any time (including all legal expenses arising in connection with such claims, losses or liabilities) and which in any way directly or indirectly relate to or are connected with the Seller's said banking business and/or the provisions of this Memorandum of Agreement, including any claims, losses or liabilities which it may incur in consequence of the failure by the Purchaser to meet ony obligation of the failure by the Purchaser to meet ony obligation transferred by the Seller to the Purchaser in terms of agreement or in consequence of any right which any employee of the Seller may have against the Seller arising out of his employment with the Seller or his transfer to the Purchaser.

# 12. ACCESS TO BOOKS, RECORDS, ETC.

The Seller and all persons authorized by the Seller shall, for such period as it may require, have free access at all reasonable times during business hours to all books papers, records and domuments relating to the said banking business handed over to the Purchaser in terms of clause 6 above.

In these conditions, other than where a particular kind of copy is specified, "copy" means copy for all matter contained in the Gazette itself and for subsidiary legislation issued as supplements to the Gazette.

1. (1) Other than by prior arrangement, only original 18852f | typing is accepted.

(2) Carbon-copies are not normally acceptable, other than in cases where the original typing has to be legally retained, elsewhere, as, for example, in the case of a proclamation.
