PARTIES:

This Agreement is entered into by and between: FINCOR FINANCE CORPORATION LIMITED ("Fincor")

(represented herein by Alistair Lpwton Calderwood, he being duly authorized thereto by a Resolution of its Board of Directors);

BARCLAYS BANK OF ZIMBABWE LIMITED ("Barclays")

(represented herein by Isaac George Takawira, he being duly authorized thereto by a Resolution of its Board of Directors)

PREAMBLE:

- A. Fincor and Barclays are both companies duly incorporated according to the laws of Zimbabwe. Fincor carries on business as a registered financial institution. Barclays carries on business as a registered commercial bank.
- B. Fincor is a public company but is not listed on the Zimbabwe Stock Exchange. All its shareholders are residents of Zimbabwe. Barclays is a public company listed on the Zimbabwe Stock Exchange. It has a very sizeable number of local individual shareholders but the ultimate majority shareholder is resident outside Zimbabwe.
- C. Fincor has an authorized share capital of 5 000 000 (five million) shares of a nominal value of 50 cents (fifty cents) each, of which 4 220 400 (four million two hundred and twenty thousand four hundred) shares were issued as at the date of signature hereof and are fully paid up.
- D. Barclays has an authorized share capital of 200 000 000 (two hundred million) shares of a nominal value of 50 cents (fifty cents) each, of which 133 128 944 (one hundred and thirty three million one hundred and twenty-eight thousand nine hundred and forty-four) shares were issued or reserved as at 1st March, 1992.
- E. The parties are desirous of merging the ownership of Barclays and Fincor ("the merger") to form a group in order to provide all the commercial and corporate banking services currently offered by Barclays, and in addition, all the services of a financial institution currently offered by Fincor.
- F. The merger is to be effected by means of an exchange of shares in terms of which all the shares in Fincor are to be transferred to Barclays, in exchange for which Barclays are to allot certain of the shares in Barclays to the shareholders of Fincor, the result being that Barclays will become the holding company of Fincor.
- G. The merger is to be conditional upon the parties obtaining the authority of the Minister of Finance, Economic Planning and Development ("the Minister") in terms of the Exchange Control Regulations, 1977, the approval of all the Fincor shareholders, and the approval of the Minister in terms of the Banking Act [Chapter 188].
- H. As the annual accounts of Fincor are only being audited up to 31st March, 1992, and as the merger may not have been effected by that date, Barclays require the control of the management of Fincor as from 1st April, 1992 ("the effective date").
- Barclays require that the paid up capital of Fincor be increased by a further \$4 220 400 (four million two hundred and twenty thousand four hundred dollars) out of undistributed profits in preparation for the merger.

NOW THEREFORE THESE PRESENTS WITNESS THAT: Accounts:

- Fincor shall procure that the annual accounts of Fincor as at 31st March, 1992 are prepared and audited in accordance with the past accounting practices of Fincor and the generally accepted principles of the accounting profession apart from the treatment of the inner reserve which will be transferred to undistributed profits. The audited accounts will be completed by no later than 22nd April, 1992, and copies of such accounts will be submitted to Barclays and to Deloitte & Touche on completion.
- Deloitte & Touche shall examine the accounts and, if satisfied, shall issue a due dilligence certificate.
- 3. In the annual accounts of Fincor for the year ending 31st March, 1992, provision shall be made for a final dividend to be paid in cash to shareholders registered as such on that date of a sum which, added to the interim dividend in

September, 1991, will amount to a total dividend for the year ending 31st March, 1992, which is $2\frac{1}{2}$ (two and a half) times covered by the after tax profits for that year, assuming a tax rate of 45%, and this final dividend shall be declared and paid on completion of the audit of the accounts.

Control of Fincor:

- 4. As at the effective date, and provided that the overall intention of the parties to merge in terms herein has been approved in principle by the Minister, Fincor shall place Barclays in control of Fincor by—
 - 4.1 Fincor allotting 1 (one) of its ordinary shares to Barclays;
 - 4.2 Fincor procuring that a majority of its shareholders shall cede the voting rights attached to their shares in Fincor to Barlcays, such cession to be effected by a Deed of Cession accompanied, if necessary, by a form of proxy;
 - 4.3 Fincor procuring that its Board of Directors will be under the control of Barlcays.
- 5. As from the effective date, Barclays shall be entitled to appoint representatives to participate with the company's secretaries and the management of Fincor in the day to day running of Fincor and shall be provided with any information which they ask for which is relevant to the annual accounts and, in particular, debtors, depositors, deferred income and securities.

Preparation for Merger:

- 6. Once the overall intention of the parties to merge in terms herein has been approved in principle by the Minister, the parties shall issue a statement of their intention in a form approved by the Minister and by both of them and by the Zimbabwe Stock Exchange.
- Once Fincor has placed Barclays in control of Fincor as provided for in terms of clause 4 herein, Fincor shall increase its authorized share capital to 20 000 000 (twenty million) shares of nominal value of 50c (fifty cents) each.

Conditions of Merger:

- The following shall be conditions of the merger being effected in terms of clause 10 herein—
 - 8.1 that the Minister shall grant formal authority in terms of the Exchange Control Regulations for the transfer of all Fincor shares to Barclays;
 - 8.2 that all the shareholders of Fincor shall approve of the terms of this agreement;
 - 8.3 that the Minister shall grant permission for the merger in terms of the Banking Act;
 - 8.4 that a statement of due dilligence shall be issued by Deloitte & Touche, Barclays' auditors, in compliance with clause 2 herein.

Merger:

- 9. Once the conditions contained in clause 8 have been fulfilled, Fincor shall increase the number of its fully paid shares up to 12 661 201 shares by way of offering to its shareholders registered as at 31st March, 1992, at their option, either a bonus issue or a dividend, the whole amount of which will be utilized to acquire shares in Fincor.
- 10. Once the conditions contained in clause 8 herein have been fulfilled and once Fincor have increased the number of its fully paid up shares in accordance with clause 9 herein, Fincor shall procure that all its shareholders shall exchange their shares in Fincor for new issued shares in Barclays in the ratio of 3 (three) shares in Barclays for 4 (four) shares in Fincor:

Provided: however, that the total number of shares acquired by the shareholders of Fincor in Barclays shall not exceed 9 495 900 shares: And Provided further that Barclays shall obtain a listing for such shares.

11. The middle market price of Barclays' shares ruling at the date of signature hereof shall be used for the purposes of recording entries in Barclays' accounts records.

Method of effect merger:

- In order to effect the merger, Fincor shall procure that all its shareholders shall—
 - 12.1 hand Barclays the share certificates with signed share transfer forms in respect of all the shares in Fincor, accompanied by a certified copy of a Resolution of the Directors of Fincor authorizing Coopers and Lybrand, Fincor's secretaries, to transfer the shares;

- 12.2 instruct Coopers and Lybrand to effect immediate registration of transfer of all the shares in Fincor to Barclays or its nominees, and hand the new share certificates to Barclays against delivery by Barclays to Coopers and Lybrand of the certificates of all the shares in Barclays to which the shareholders of Fincor will become entitled, for distribution to them.
- 13. The date of the merger ("the merger date") shall be deemed to be the date as shown on the share certificates issued by Barclays to Fincor shareholders as provided for in clause 12.2 herein, and if such share certificates bear different dates, then the merger date shall be deemed to be the last of such dates.

Ordinary Business:

14. During the period from the date of signature of this agreement to the effective date, Fincor shall continue to conduct its business in the ordinary way in all respects in accordance with its past business practice and no transactions other than transactions in the ordinary course of business of a finacial institution shall be entered into without the prior consent of Barclays.

Cancellation of Agreement:

15. In the event of the parties being unable to obtain fulfilment of any of the conditions set out in *subclause* 1, 2, or 3 of *clause* 8 by no later than 30th June, 1992, or in the event of the parties being unable to obtain fulfilment of the conditions set out in *subclause* 4 of *clause* 8 by no later than 30th April, 1992, then, in any such event, either party shall be entitled to withdraw from this agreement which shall thereupon fall away and become of no force or effect and neither party shall have any claim in terms of it against the other party.

Compliance with Law:

16. As at the effective date, Fincor shall have complied with all legal requirements in respect of its affairs under the Companies Act, the Banking Act, and the Income Tax Act and any other relevant legislation.

Exclusion of Liability:

- 17. During the period in which Barclays is in control of Fincor as set out in *clauses* 4 and 5 herein, and before the merger date, Barclays shall not be liable for any loss or damage caused to the shareholders of Fincor by reason of any negligent act or omission by its servants or agents.
- 18. During the period from the effective date to the merger date, Barclays shall procure that the business of Fincor shall continue to be conducted in the ordinary way in all respects in accordance with Fincor's past business practice and that no transactions other than transactions in the ordinary course of business of a financial institutions shall be entered into.

Restraint of Trade:

19. Fincor shall procure that Alistair Lawton Calderwood, Roger Campbell Hounsell, John Richard Sly and Basil Kaufman, will give an undertaking to Barclays not to interest themselves either directly or indirectly, and whether personally or through their family or investment companies in Zimbabwe in any financial institutions in Zimbabwe other than Fincor, and whether as a director, shareholder, consultant, employee or otherwise, for a period of 2 (two) years from the merger date:

Provided, however, that this restriction shall not be construed as preventing any of the above persons from holding office as a director of a merchant bank or from holding shares in a quoted company or investing as an ordinary depositor or from preventing John Richard Sly from taking up an appointment as a director of Standard Chartered Bank of Zimbabwe Limited, provided that he resigns from the Board of Directors of Fincor before doing so.

Service Agreements:

- Barclays undertakes to do all in its power to ensure that on and after the effective date Fincor shall continue to—
 - employ Gerald Craigen as Chief Executive on terms and conditions contained in a separate written contract; and
 - 20.2 employ the remainder of its present staff on terms and conditions no less favourable than those on which they are now employed.

Actuarial Assessment:

21. Fincor shall forthwith obtain from Old Mutual the actuarial assessment of its pension fund for 1991. In the event of there being any shortfall in contributions, provision shall be included by Fincor in its annual accounts as at 31st March, 1992 for this shortfall to be made good out of past retained profits.

Costs:

 Each party shall pay its own costs in connection with this agreement and the preparation thereof.
