ROAD MOTOR TRANSPORTATION ACT [CHAPTER 262]

Applications in Connexion with Road Service Permits

MINES AND MINERALS ACT [CHAPTER 165]

Exclusive Prospecting Order No. 866: Harare Mining District

THE following order is published in terms of subsection (2) of section 92 of the Mines and Minerals Act [Chapter 165]:

- "I, Eddison Jonas Mudadirwa Zvobgo, Minister of Mines, with the approval of the President, hereby, in terms of subsection (1) of section 92 of the Mines and Minerals Act [Chapter 165], make an exclusive prospecting order, in favour of Prospecting Ventures Limited over the area described hereunder, in the Harare mining district, in relation to map reference Copper Queen SE-35-8 of the Third Edition and of the Scale 1:250 000, produced by the Surveyor-General, subject to the following conditions-
 - (a) the order is made in respect of gold;
 - (b) the concession holder shall carry out prospecting operations in a manner satisfactory to the Minister of Mines, and shall comply with the terms of the Mines and Minerals Act [Chapter 165];
 - (c) all pits and trenches dug during prospecting operations must be backfilled and levelled; and
 - (d) the unnecessary destruction of vegetation must be discouraged.

Prospecting Ventures Limited is authorized, in terms of subsection (4) of section 94 of the Minerals Act [Chapter 165], to prospect on all registered base mineral blocks which were not being worked or developed on the 14th May, 1993, being the date of the lodging of this order.

Description of area

An area of approximately 56 054 hectares situated in the Harare mining district and bounded by a line commencing at a Secondary Trigonometrical Station 1326 which is approximately 60 kilometres west-north-west of Chinhoyi (grid reference 35KQL823932); thence proceeding on a true bearing of approximately 133° for a distance of approximately 21,8 kilometres to a point (grid reference 35KQL981782); thence on a true bearing of approximately 209° for a distance of approximately 26,4 kilometres to a point (grid reference 35KQL852553); thence on a true bearing of approximately 305° for a distance of approximately 19,4 kilometres to a Secondary Trigonometrical Station 1312 (grid reference KQL694667); thence on a true bearing of approximately 25° for a distance of approximately 29,5 kilometres to the starting point.

The rights granted under this order may be exercised for a period of one year with effect from 11th March, 1994, to the 10th March. 1995, inclusive.
