LAND ACQUISITION ACT, 1992

Notice of Inquiry to Determine Whether or Not to Declare Land Derelict

IT is hereby notified that, in terms of section 42 of the Land Acquisition Act, 1992, that the Derelict Land Board intends to hold an inquiry for the purpose of determining whether the piece of land described in the Schedule should or should not be declared derelict.
