Interim Report

The economy continues to recover slowly. The mining sector's growth was sluggish while the manufacturing sector declined by 8,2% during the three months to December, 1993. Despite the poorer than expected ending to the 1993/1994 rainy season, national maize production is estimated at 2,3 million tonnes of which 1,2 million tonnes are expected to be delivered to the Grain Marketing Board. While prices for this year's quality tobacco crop are likely to remain depressed in US dollar terms, because of the devaluation of the Zimbabwe dollar on 31 December, 1993, the average local price of tobacco should be higher than that for 1993.

Money supply (M2) growth continues to be a cause for concern having risen from 25,9% in September, 1993 to 56,6% in March, 1994. This was due to increased borrowing from the public sector, primarily to fund current consumption. As a result of increased liquidity in the market, the 90 day Negotiable Certificate of Deposit rate has been stable at around 27% since September, 1993 and the rate of inflation firmed slightly to 19,1% in February, 1994. Following the relaxation of exchange controls and the introduction of corporate Foreign Currency Accounts, the premium between the interbank market rate and the Reserve Bank rate declined from 5% to around 2%.

Overall, the prospects for economic growth are brighter than at the same time last year because of the relatively good harvest and the slight upturn in the world economy. Therefore, provided the public sector exercises greater financial discipline, economic growth is expected to rise from 1,7% in 1993 to about 3% in 1994.

The Group's Balance Sheet has been restated in keeping with current bank accounting practices. Accordingly, the comparative figures for 1993 do not correspond with figures in the 1993 Interim Report. The Group's unaudited net after-tax income for the six months period ended 31 March, 1994 was \$20 215 000, \$5 821 000 or 40% higher than that for the comparable period last year. As a result of the Rights Issue on 27 August, 1993 and the 415 725 shares issued under the Executive Staff Share Option Scheme, the number of shares in issue has risen since 31 March, 1993 from 16 360 850 to 24 969 600. Earnings per share, which for the period under review have been calculated on the weighted average of 24 715 889 shares in issue, have decreased from 87,98 cents to 81,79 cents.

Dividend Announcement

In view of the increased income the Directors are pleased to announce the declaration of an interim dividend for the six months ended 31 March, 1994 of \$4 869 000 (1993: \$3 027 000). This equates to 19,5 cents (1993—18,5 cents) per share payable to Shareholders registered in the books of the Company at the close of business on Friday, 6 May, 1994. This dividend is 4.15 times covered.

The transfer books and the register of members will be closed from 7 May, 1994 to 9 May, 1994, both days inclusive. Dividend cheques will be posted to Shareholders on or about 17 May, 1994. Shareholders' tax will be deducted at the rate of 15% where applicable.

- (a) the Instructions Relating to the Drafting and Typing of Legislation (Attorney-General's Circular 1 of 1978); and

which two booklets are intended for complementary use.

In these conditions, other than where a particular kind of copy is specified, "copy" means copy for all matter contained in the *Gazette* itself and for subsidiary legislation issued as supplements to the *Gazette*.
