 - (a) the name and address of the advertiser; and
 - (b) the debtor's code number, if any; and
 - (c) the required date or dates of publication.
- 10. If a typographical error occurs in the Gazette, it is rectified as soon as possible by a correcting notice without charge to the ministry or department concerned, subject to the following conditions—
