### 1. MIDLANDS PROVINCE TOURISM DEVELOPMENT ZONE

An area of land bounded by a line drawn from the intersection of Umsweswe river by the northern boundary of Rock Bar Ranch eastwards along the Umsweswe river and southwards along the eastern boundary of State Land to its intersection by an unnamed road linking Bumbere and Manyene Business Centre; eastwards along the latter road southwards from Manyene Business Centre passing through St. Cuthberts, Muchemwa and on the western side of Mafindindi and straight to the provincial boundary; hence southwards along an unnamed road along the western boundary of Manyoni; eastern and southern boundaries of Kuwirirana and along the northern and western boundaries of Mahamara Ranch following a road and westwards, proceeding westwards along the latter river southwards, westwards along the eastern and southern boundaries of Morena Ranch, Mazuri Ranch and Parlona to its intersection by an unnamed road on the northern boundaries of Mvurachena and Xmas; eastwards, southwards and northwards along the northern eastern and southern boundaries of Xmas, Sebakwe and Pieterdale properties; south westwards from the northern boundary of Mahamara Ranch following a road and westwards, north westwards following an unnamed road on the southern and western boundaries of East Range Ranch to Sebakwe proceeding along Nyamaponde river to its intersection by an unnamed road westwards along the road to Umlala park; south eastwards leaving the road before Gold Ridge along the eastern boundaries excluding Matchebel, Congela, Webleign, Erin and Moyo; to the northern boundary of Chiwundura communal

land; thence westwards following the district boundary line on the southern boundary of Albany; following the latter boundary and along the southern boundaries of Albany, Hashu and State land to its intersection by Umtebekwana river; southwards along the latter river to its intersection by a road from Zvamabonde along the northern boundaries of Edwards farm and Illingden; westwards along the road to its intersection by the road from Shurugwi and then southwards along the Shurugwi road; westwards leaving the latter road to take another one following the northern boundary of Ortner to its intersection by the Runde river; south westwards along the southern boundary of Shangwe Estate to its intersection by a road from Gweru; southwards cutting across Mavhumashaba and Brooklands along the latter road; westwards leaving the Gweru road to take another one leaving to its intersection by the railway line to Somabhula on the eastern boundary of Nubble; thence generally south westwards following the railway line to Somabhula and westwards north westwards along the southern, western and eastern boundaries of Browns, Lewis; East Lynne Estate; the Meadows to its intersection by the Vungu river along the northern boundary of the Meadows, north westwards along the latter river to its intersection by the southern boundary Rijov; north eastwards along the southern and western boundaries of Rijov and Ngamo river; northwards along the latter river to its intersection by the Gweru river; proceeding in that north easterly direction along the eastern and northern boundaries excluding Retreat, Ranch farm, Somerset Estate and Missouri to its intersection by the district boundary line on the southern boundary of Ingle Nook proceeding generally westwards along the southern boundary of Ingle Nook and northwards along the western boundaries including Ingle Nook, Bellevue, Monte Bello, Longwood, Paris and Argyle to its intersection by the Rhino river; north eastwards along the latter river to its intersection by the Sebakwe river on the south eastern boundary of solitaire; thence south eastwards, north eastwards and south eastwards along the southern, eastern and northern, eastern and northern boundaries of the following properties; Hatchland, Long valley, Belgrave, Dia Weiveld, Sherwood Block Estate, Loozani Estate and Mopani park; to its intersection by the Kuvizha river; northwards along the latter river to its intersection by the Munyati river; thence generally north westwards along the Munyati river and north eastwards; thence it proceeds cutting across the State land and along the eastern boundary of Rock Bar Ranch to the starting point.

### 2. RHODES-MATOPOS

An area of land bounded by a line drawn from the eastern boundary of Rhodes-Bulawayo sanctuary; eastwards along the

northern and eastern boundaries of Sanendale Block to the northern most beacon of Inyonga south eastwards along the eastern and northern boundaries of Adams Farm; generally southwards along the eastern boundaries of the latter property and Florencedale; thence southwards along the Charezi river to its intersection by the northern boundaries of Wenlock Communal Land; proceeding generally south eastwards and again south eastwards along the northern, western southern boundaries of Wenlock Communal Land and A Zwemele Block to the northern most beacon of sheet; thence along the northern and western boundaries of the latter property and Mount Orquil Ranch to the northern most beacon of the latter property proceeding generally south westwards along the western boundary of Mount Orquil Ranch, thence westwards towards Sibona cutting across Wenlock Communal Lands to its intersection by the Tuli river; southwards along the latter river towards Sitezi Primary School; thence northwards before Sitezi Primary School and again in a westerly direction to its intersection by the district boundary; northwards along the latter boundary along the western and southern boundaries of Toko North, Damara Estate, Unfula, Mapani Poort, Buluma, Vergenoeg to the southern most beacon of Koodoo; thence along the southern boundary of the latter property and along the south western boundaries of Victory, Goede Hoop, Malala, Lushongwe, Mavuli, to the northern most beacon of store and along the northern boundaries of the latter property and Mt. Edgecombe to its intersection by the Shashani river; up along the latter river to its intersection by the southern most beacon of Nauder Rest; thence south-eastwards along the western and southern boundaries of Nauder Rest and Darnaway to its intersection again by the Shashani river on the western boundary of three streams; north eastwards along the Goede Hoop, Vriegericht south to its intersection by the Bulawayo-Plumtree Road; proceeding generally northwards along the eastern boundaries of Marcdale, Maritzburg to the latter eastern most beacon on the south of Doublevale; thence south eastwards and north eastwards along the southern and eastern boundaries of Honey Bird Kop, Klipspring to its intersection again by the Bulawayo-Plumtree road; north eastwards following the latter road on the southern and eastern boundaries of Willandale, Fairview, 20 of Willandale to the southern boundaries of Rangemore; thence south westwards along the northern boundaries of Valindre and 17 of Willandale Estate and northwards to the starting point.

### 3. KARIBA AND ZAMBEZI VALLEY

An area of land bounded by a line drawn from the intersection of Matetsi river and Zambezi river; (which forms the Zimbabwe-Zambia intersectional boundary line; hence generally northwards, and along the latter boundary to its intersection by the Zimbabwe-Mozambique international boundary line on the northern boundary of Dande Communal Land; proceeding southwards, and generally eastwards along the Zimbabwe-Mozambique international boundary line to its intersection by the Nyarandi river at Mukumbura business centre; south eastwards along the latter river and westwards along an unnamed road that cuts across Chisiwiti and Mukumbura Communal Lands in a generally straight line passing through the southern boundary of Kaitano, Mukoma, Hoya Business Centre and Nyakudututu; Southwards along the unnamed river passing through the eastern boundary of Machaya to Meseredza; eastwards from Meseredza on the northern boundary of Charunda on straight line to its intersection by the Mbwadzi river; southwards along the latter to St. Albert's Mission; hence southwards along Kanyama river and southwestwards leaving the river proceeding along the eastern boundary of Stanmore to its intersection by the Muruwa river; northwards, westwards and southwards along the latter river to the southern boundary of Charlton, Whistle Field, Heresford Estate along the Aurelia river; proceeding along the southern boundaries of Sandy land and palms to the northern boundary of Ternanog; southwards from Ternanog along the eastern boundaries including Ternanog; Magondo Estate Tenenge and Mabubu to the western boundaries of Chidikhamwedzi; northwestwards including Mabubu, Taikoo and Taisecka to its intersection by the Dande

river; proceeding northwards along the latter river to Guruve Business Centre; northwards proceeding along the Guruve-Bakasa cutting across Dunavety, Blue Jay, Makombi, Nyamsewe and Camperdown to the southern boundaries of Chireingwe; westwards and southwestwards along the northern boundary of Guta Hill (now State Land), Cela Viendra A and the eastern boundary of Rungudzi Estates straight to intersection by the Dande river; proceeding in a southward direction along the eastern boundary of Kachuuta Communal Lands to its intersection by the Manyame river; southwards along the river and generally westwards boundaries of State Land, Mukamba, Smith Field, Northend, Tsandwa and Rosetta; hence northwards, southwards and westwards following an unnamed road from Rosetta passing through Kosana Ranch, Redwing, Green Valley Estate, Ona Patai Estate, Chenene, Wolwehock, Chimsenga, Victory Estate, Ridziwi and Kanenje, to its intersection by the Angwa river; northwards along the eastern and northern boundaries of Mafalo (now State Land), Rollingwood, Sipo Feneni, Riwanzi, to Bakwa where it intersects an unnamed road; proceeding in that northwesterly direction following the road from Bakwa passing through Kabiri Business Centre, west of Katsanga, east of Danga, west of Nyama near Manyenyedzi; westwards and northwards along the southern boundary of Manyenyedzi, Mahwau, through Chitandiwa Business Centre to Kavidza; proceeding westwards from Kavidza to its intersection by an unnamed river; southwards along the latter river to its intersection by the road from Makuti; hence southeastwards, southwards and south westwards along the road that cuts across Vuti; southwestwards from the western boundary of Nyadza along the southern boundary of Nyadza Communal Land along the Gachegache river to its intersection by the District boundary line on the northern boundary of Nyagwisi, southwards along the district boundary through Nyagwisi Nyadara and across the Kanyati river to its intersection by Magunje-Zipano road on the southern boundary of Deve; generally southwards and southwestwards along the latter road through Chiro, Magororo, Musampakaruma, Chidyamugwamu to Kasvisva proceeding northwards from Kasvisva along the Wadze river and Ume river to Siyakobvu on the western of Nebiri; southwestwards along the road from Siyakobvu passing through Negande to its intersection by the Chikandamwenda river; westwards along the latter river across the Sengwa river to its intersection by the road from Siyamupa; southwards along the road to Siabuwa; hence eastwards following another road passing through Maluba, Karungwizi, and northern eastern boundaries of Nengunga and Zhomba; proceeding southwards passing through the northern and eastern boundaries of Matungura to Mutimutema Business Centre; hence southwards, southwestwards following an unnamed road through Musita, Sunganayi, Huchu, Charamba, Kasongo, and Zhomba, northwards and westwards along another road cutting across Ngololo, Chitau, Busi Communal Lands, proceeding along the eastern and the northern boundaries of Naluba; westwards following the road through Chusya and Lusulus Business Centre northwestwards and generally westwards along Kabuda, Lubu, and Sebungwe rivers to its intersection by road on the northern boundaries of Siachilaba, southwards and generally southwestwards along the road through Sianzundu along the eastern and southern boundaries of Saba; along the eastern boundaries of Mupambe; hence southwards before Simbala along the eastern boundaries of Lubanda and westwards along Kapanga river, northwestwards northeastwards and generally westwards along Gwai river to the northern boundary of Chibala; hence westwards and northwards along the southern boundaries of Simangani; passing through northern boundaries of Mwemba and western boundaries of Kasese to the starting point.

### 4. MUDZI

An area of land bounded by a line drawn from the intersection of Mazowe river and the Zimbabwe-Mozambique international boundary line; thence eastwards and southwards along the latter boundary line to its intersection by the Rwenya river southwestwards along the Rwenya river and northwestwards along

the eastern and northern boundaries of Nyamhanza A XIX Nyamhanza BZIX and Chimoyo Bx; northwards from Chikukwa along an unnamed road passing through Mavhudzi to Mudzi Business Centre; westwards, northwestwards along the road that connects to Mudzi Business Centre, Chifamba, Kamsori, Chindoko to its intersection by the Nyadire river; eastwards and northeastwards along the latter river and a southern boundary of Chagonda xi to Guyu where it intersects Chitsungu-Mutawatawa Business Centre road; southwestwards along the latter road to Masindima; hence leaving the road proceeding southwards following Katiyo river and again intersected by the latter road at Chikukwa, southwards following the road to Morris and westwards to its intersection by the south most beacon of Mondesir; hence northwestwards along the southern and western boundaries of Mondesir; Nherera new Brixton Wolley Estate, Vapley to its intersection by the Shamva-Madziva Mine Road; northwards along the latter road to Mudzingi; thence along the western and northern boundaries of Odenferra, Colen Dry, Zvomanyanga; still in that northerly direction proceeding along an unnamed river passing through the eastern side of Chomagora and into an unnamed road leading to its intersection by the Mount Darwin-Nyamahobobo road following the latter road in an easterly direction leaving it at Nyamahobobo, to follow another road in the southeastern direction; thence eastwards and northeastwards along the road passing through Makachi Nyamatikiti, south of Chaparadza, Mazika, Marymount Business Centre, Chitange and Nyamuzeya to its intersection by the Tumbwi river, cutting across the Chimhanda Communal Lands, proceeding north eastwards along the latter river to its intersection by the Zimbabwe-Mozambique international boundary line; southeastwards and southwards along the latter boundary to the starting point.

#### 5. EASTERN HIGHLANDS

An area of land bounded by a line drawn from intersection of Rwenya river by the Zimbabwe-Mozambique international boundary; (Gairezi river) southwards along the latter boundary to its intersection by the Save river; thence generally northwestwards and northwards along the Save river to its intersection by the Odzi river; proceeding northwards along the latter river to its intersection by the Muwengesi river and Mutare-Mandarume road; northwards along the latter road to Musabayana and westwards along the road to Berzerly bridge; northwards from Berzerly bridge along Odzi river to its intersection by the Chigwandauri river at Nyamazura; proceeding north westwards along the latter river and northwards along an unnamed road to the western and eastern boundaries of lee and lowlands; generally northwards and eastwards along the southeastern boundary of Nyamangura xxii cutting across the Manyika Communal Lands through Sherukuru Business Centre, Beithania, Newenga to the western boundaries of Shitowa; thence northwards along the western boundary of Erin Forest Land, York Forest Land, Colen Spay to its intersection by the Chidiyo river; proceeding northwards and eastwards along the latter river and along the northern boundaries of Withington, Manjoro, Nyangani to the eastern boundary of Ngararwe where it intersects Ngarawi river; eastwards along the latter river to its intersection by the Nyamhuka-Nyautare Business Centre road, thence northwards along the latter road passing through Nyajezi Business Centre, St. Monicas, Nyautare Business Centre to Emmanuel where it is intersected by the Emmanuel-Regina Coeli road, northwards along the latter road through Tsengerai, Chifamba and Renza to its intersection by the Rwenya river to the starting point.

#### 6. LAKE CHIVERO AND MANYAME

(3) If copy comprises two or more sheets of paper, all sheets must be numbered consecutively, in arabic figures, preferably in the top right-hand corner.

(4) Where any matter is added after the copy has been prepared, and such additional matter results in one or more sheets being inserted between those already numbered, all sheets must be renumbered from there onwards—not, for instance 7, 7b, 8, *et cetera*.

4. Photographic copy or copy produced on a duplicating machine may be accepted if it is abundantly clear.

5. (1) Should any copy—

(a) exceed 10 pages of double-spaced typing on size A4 paper; or

(b) contain tabular or other matter which involves complicated setting;
