- If a consumer exceeds the allocation on three consecutive occasions, a restriction disc will be inserted for a period of 4 months.
- Use of hosepipes and use of portable water for brick moulding remain banned.

Consumers are required to monitor their daily consumption of water by reading their water meters daily. This will help detect any unnecessary loss of water.
