COMPETITION ACT [CHAPTER 14:28]

Notice of Order in terms of Section 31 (4) of the Competition Act [Chapter 14:28]

IT is hereby notified, in terms of section 31(4) of the Competition Act [Chapter 14:28] that the Competition Act and Tariff Commission (hereinafter referred to as the "Commission") conducted a full-scale investigation, in terms of section 28 as read with section 33 (5) of the Competition Act [Chapter 14:28] (the Act) into the compliance of Total Zimbabwe with the conditions imposed by the Commission on the approval of the Total Zimbabwe/Mobil Oil merger on 26th January, 2006.

The Commission at its 41st Ordinary Meeting held on 22nd October, 2010, considered Total Zimbabwe's submissions and those of the stakeholders and resolved that Total Zimbabwe was not complying with the conditions of approval of the 2006 Total Zimbabwe/Mobil Oil merger and published its proposed order in the Government Gazette of 28th January, 2011. Total Zimbabwe and the relevant stakeholders were requested to make representations on the proposed order to the Commission in terms of section 31 (5) of the Competition Act, and they duly did so.

The Commission considered Total Zimbabwe's representations and those of the interested stakeholders at its 44th Ordinary Meeting held on 28th April, 2011 and resolved to make a final order in terms of section 31 of the Act as follows:

1. THAT the service stations to be disposed of by Total Zimbabwe to interested indigenous entrepreneurs should be those that became excess as a result of the merger in that the merged party ended up having more than one service station along the same road or street, or in the same area, within a distance of 500 metres between the stations.
2. THAT the fuel depots to be disposed of by Total Zimbabwe to interested indigenous entrepreneurs should be those that became excess as a result of the merger in that the merged party ended up having more than one depot in the same town or province.
3. THAT Total Zimbabwe should submit a complete list as at the date of this Order of all its service stations and fuel depots in the country including details of the respective physical addresses and indicating those identified for disposal as "Excess Assets" for approval by the Commission before inviting by way of advertisements in the national newspapers, offers for purchase of such "Excess Assets" by interested indigenous entrepreneurs.
4. THAT Total Zimbabwe and the interested indigenous entrepreneurs engage independent evaluators that are mutually agreed between them to evaluate the service stations and fuel depots to be disposed of.
5. THAT Total Zimbabwe should honour all agreements that Mobil Oil Zimbabwe had with other industry players on the use of Mobil Oil Zimbabwe's assets for their operations, including hospitality arrangements, supply arrangements, contract arrangements and dealership arrangements to ensure the maintenance of competition in the relevant market.
