Collective Bargaining Agreement: Catering Industry

IT is hereby notified that the Minister of Public Service, Labour and Social Welfare has, in terms of section 80(1) of the Labour Act [Chapter 28:01], published the Collective Bargaining Agreement set out in the schedule which further amends the agreement published in Statutory Instrument 167 of 1991 and is registered in terms of section 79 of the Act.

SCHEDULE

NATIONAL EMPLOYMENT COUNCIL FOR THE CATERING INDUSTRY

COLLECTIVE BARGAINING AGREEMENT: CATERING INDUSTRY

Further Agreement

This further agreement, made and entered into between the Catering Employers' Association of Zimbabwe (hereinafter referred to as "the employers" or "the employers organisation"), of the one part and the Zimbabwe Catering and Hotel Workers' Union (hereinafter referred to as "the employees" or the "trade union"), of the other part being the parties to the National Employment Council for the Catering Industry of Zimbabwe shall be read as one with the principal agreement published in Statutory Instrument 167 of 1991 (hereinafter referred to as "the principal agreement"). In order to effect the wishes of the Council, the under mentioned amendments to the principal agreement are required as indicated below—

Wages, Grading and Increments

Clause 10(1) of the principal agreement as read with Annexures A, B and C is hereby deleted, and the following inserted in place thereof—

"10. (1)(a) Every employer shall place each employee in the grade prescribed appropriate to his/her occupation and shall with effect from 1st November, 2020 to the 31st January, 2021, pay wages to such employee of at least the amount reflected thereunder for the employee's grade and class, and no employee shall accept wages amounting to less than the amount prescribed for him/her:

Provided that establishments that are trading in foreign currency and are able to pay remuneration in part or in full in foreign currency are encouraged to do so:

Provided, further that any party is free to seek review of this agreement if there are material changes in the economy.

Transport allowance, Housing allowance and meals

Clause 15 (1) and (2) of the principal agreement are herby deleted, and the following inserted in place thereof—

"15. (1) Every employer shall pay a transport allowance of Z\$2 200,00, per month to each employee for the period 1st November, 2020, to 31st January, 2021 except—

- (a) where material transport is being provided free of charge by the employer to such employee;
- (b) where free accommodation is provided within the premises of the employee's place of work;
- (c) where such accommodation is provided outside the premises but within a reasonable walk able distance from the employee's place of work;
- (d) where the employee resides within a reasonable walk able distance from his or her place of work:

Provided that establishments that are trading in foreign currency and are able to pay the allowance in part or in full in foreign currency are encouraged to do so.

Provided, further that any party is free to seek review of this agreement if there are material changes in the economy.

Provided that where a dispute arises as to the interpretation of this provision, either party shall refer the matter to the Exemptions/Retrenchment Committee for consideration and determination in terms of clause 5 of the principal agreement.

15(2) "Every employer who does not provide free accommodation to his employee shall pay a minimum accommodation allowance of Z\$820,00, per month for the period 1st November, 2020, to 31st January, 2021.

Provided that establishments that are trading in foreign currency and are able to pay the allowance in part or in full in foreign currency are encouraged to do so:

Provided, further that any party is free to seek review of this agreement if there are material changes in the economy.

Declaration

The employers' organisation and the trade union, having arrived at the agreement set forth herein, the undersigned hereby declare that the foregoing is the agreement arrived at and affix their signatures hereto. Signed at Harare, this 20th day of October, 2020.

IT is hereby notified that the Minister Labour and Social Welfare has, in terms of section 80 of the Labour Act [Chapter 28.01], approved the publication of the Collective Bargaining Agreement set out in the Schedule and registered in terms of section 79 of the Labour Act [Chapter 28.01].

SCHEDULE

NATIONAL EMPLOYMENT COUNCIL FOR THE WELFARE AND EDUCATIONAL INSTITUTIONS

COLLECTIVE BARGAINING AGREEMENT

Collective Bargaining Agreement entered into between the Welfare and Educational Institutions Employers Association (hereinafter referred to as "the employer"), of the one part, and Zimbabwe Educational Scientific Social and Cultural Workers Union (hereinafter referred to as "the employees or trade union"), of the other part, being parties of the National Employment Council for the Welfare and Educational Institutions.

Notwithstanding the date of registration and publication hereof, this agreement shall be deemed to have come into operation with effect from the 1st of October, 2020 to the 31st of December, 2020.

- With effect from the 1st of October, 2020, every employer shall pay not less than the minimum wage to each employee who has not completed 12 months of service as prescribed in the appropriate part of the schedule for the occupation of the employee.
 - The provisions of this agreement are minimum employment conditions on wages, salaries and benefits.
 - Subject to the provisions of the Labour Act [Chapter 28:01], workplace negotiations to top up on this agreement are permissible.

Collective Bargaining Agreement: Welfare and Educational Institutions

- Where employees are receiving more favourable wages and benefits than those specified in this agreement, these shall not be withdrawn.
- If a worker was being paid <u>MORE</u> than the minimum wage for his grade prior to the 1st of October, 2020, the cash differential between that wage and the relevant new minimum wage <u>MUST</u> be maintained.

NEC levies and trade union dues are deducted on the actual salary/wage of an employee. NEC dues are 2% from the employer and 2% from the employee giving a total of 4% while Union dues are 4% for the employee, all payable monthly. Employers Association subscriptions to be paid in accordance with their terms and conditions.

2. Interpretation of Terms

In this agreement-

"Early Childhood Education Development Centres (ECDs)/ Nursery Schools/Pre-Schools" "means centres for the early

- development of children from the age two in preparation for primary education;
- "Employers Association" means the Welfare and Educational Institutions Employers Association;
- "Employers Association dues" means contributions made by the employers for the administration of the Employers Association in terms of section 52 of the Labour Act [Chapter 28:01];
- "Independent A-Trust Schools" means schools which are run by registered trusts or board of governors whose employees are employed by the trusts or boards of governors;
- "Independent B—Private Schools" means schools which are run and managed by private individuals or organisations and whose employees are either employed by the private individuals or organizations;
- "Independent C-Private Colleges" means colleges which are run by private individuals or organisations which provide for academic and professional courses. The employees are employed by private individuals, organisations or registered companies.
- "Independent D-Home Schools A" means private schools which operate from a residential property or a home set up with an enrolment of between 1–50 students, which are run by individuals, organisations or private companies whose employees are employed by the same.
- "Independent D-Home Schools B" means private schools which operate from a residential property or a home set up with an enrolment of 51 students and above, which are run by individuals, organisations or private companies whose employees are employed by the same;
- "Independent E-Boarding" means any boarding school whose employees are employed by SDCs which are not mission schools, independent schools, local authority schools or government schools;
- "Independent F-Day-Urban" means any day school in urban areas whose employees are employed by SDCs which are

- not mission schools, independent schools, local authority schools or government schools;
- "Independent F-Day-Rural" means any day school in rural areas whose employees are employed by SDCs which are not mission schools, independent schools, local authority schools or government schools;
- "Mission Boarding Schools" means schools which are run by religious organisations as the responsible authority which offer boarding facilities. The employees are either directly employed by the responsible authority or SDC;
- "Mission Day Schools" means schools which are run by religious organisations as responsible authorities which do not offer boarding facilities. The employees are either directly employed by the responsible authority or SDC;
- "Mission Hospitals and Clinics" means health care institutions which are run by religious organisations and whose employees are employed by the responsible authority;
- "NEC levies" means levies which employers and employees are statutorily required to pay NEC for its operations and these are compulsory
- "Non-Governmental Organisations" means registered Private Voluntary Organisations which operates in Zimbabwe and provide relief and developmental assistance to communities;
- "Private ECDs" means ECDs which operate on a private school and are run by private individuals, organisations or registered companies whose employees are employed by the same;
- "Religious Organisations (Administrative Offices)" means places where the church administration is done;
- "Religious Organisations (Presbyteries and Convents)" means places where Ministers stay of their domiciles;
- "Rural ECDs" means ECDs which are located in a rural set up and are run by private individuals, organisations or registered companies whose employees are employed by the same;
- "Tertiary Institutions" means colleges, training institutions and universities which are run by non-governmental

- organisations e.g. religious organisations (Churches) or other organisations, whose employees are not employed by government or local authorities.
- "Trade Union" means the Zimbabwe Educational Scientific, Social and Cultural Workers Union.
- "Trade Union Dues" means the subscriptions which employees pay through check off system upon filling in stop order forms and employers are required to deduct and to remit to the Trade Union in terms of section 54 of the Labour Act [Chapter 28:01].
- "Trust ECDs" means ECDs/Nursery Schools/Pre-schools which operate under trust schools and are run by the board of governors or trusts whose employees are employed by the same
- "Urban 1 ECDs" means ECDs which are located in low or medium density suburbs which are run by private individuals, organisations or registered companies whose employees are employed by the same.
- "Urban 2 ECDs" means ECDs which are located in high density suburbs which are run by private individuals, organisations or registered companies whose employees are employed by the same.
- "Welfare A" means registered Private Voluntary Organisations that provide institutional care to persons or animals and charge a nominal fee for the services and these rely on donations and grants.
- "Welfare B" means registered Private Voluntary Organisations providing institutional care to persons or animals but do not charge fees for the service.
- "Welfare C" means institutions which are run by registered Private
 Voluntary Organisations as special education institutions
 and/or training institutions and rehabilitation institutions
 for physically and mentally handicapped people which are
 required to be registered in terms of the Education Act and
 Manpower Planning and Development Act. These charge
 fees for service provided.

"Welfare D" means registered private voluntary organizations which provide institutional care, support, protection, home and educational facilities to children who are orphaned, abandoned, and vulnerable and who are in need of care. These are run by local or international organizations, depend on donations and grants for funding and do not charge fees for the services provided.

Differential Between Grades

The grade differential shall be 5%.

4. Subsistence Allowances (For All Sectors)

Subsistence Allowance shall be paid to those employees who have to travel away from home on employer's business. These shall be paid as follows:

 Breakfast
 - RTGS \$120

 Lunch
 - RTGS \$120

 Dinner
 - RTGS \$120

 Out of Pocket
 - RTGS \$120

5. Transport Allowance

Transport allowance shall be paid to employees not residing on employer's premises and who are not provided with free transport.

6. Housing Allowance

Housing allowance means an allowance paid to an employee towards payment of rent, water and electricity. Housing allowance shall be paid to employees who are not provided with free accommodation by the employer.

7. Recognition of Service

Every employee who has completed at least (12) months of continuous service shall, in addition to the prescribed wage, be paid an additional 1% of the prescribed monthly wage for EACH year of completed service.

Collective Bargaining Agreement: Welfare and Educational Institutions

8. Educational Allowances

8.1 Mission Schools and Hospitals

- Education Allowances shall be 75% of both tuition and boarding fees for the respective school where the employee works and in the case of a mission hospital, 75% fee of the nearest mission school.
- The guiding principles for the fees to be paid are the fees paid per child at the mission school where the employee works. If there is no school at the work place, the employer pays 75% fees of his own denomination's nearest school. If the children go to a Local Authority school whose total fees are less than the 75% to be paid, then the employer pays 100% fees to the Local Authority School.
- The fees shall be on production of school invoices and paid directly to the school concerned and the employer shall be entitled to claim proof of payment thereof and these amounts are payable for 2 children.

8.2 Early Childhood Development Centres and Creches

100% for 2 children

8.3 <u>Independent Educational Institutions and Special Schools</u> Operated by Private Voluntary Organisations

• Educational Allowances shall be 75% of fees payable at local authority and governmental schools for not more than three (3) biological children of an employee

9. Proved Expenses

The employer shall pay the necessary accommodation and all subsistence expenses.

10. Overnight Accommodation

In all cases where employees are required to sleep away from home on employers' business, they shall be provided with overnight accommodation. Sleeping in motor vehicles or buses shall not constitute accommodation.

11. Night Shift Allowance

Where employees are required to work night shift, they shall be paid 1% of the monthly salary rate multiplied by the number of nights worked.

12. Funeral Allowance

Where an employee has a funeral policy, any shortfall on the total cost of a coffin shall be paid by the employer or where an employee does not have a funeral policy the employer shall pay 50% of the coffin.

Declaration

The Employers' Organisation and the Trade Union having arrived at the agreement set forth herein, the undersigned hereby declare that the foregoing is the agreement arrived at, and affix their signatures hereto.

The agreement has been registered in terms of section 79 of the Act.

COLLECTIVE BARGAINING AGREEMENT

Further Agreement

This further agreement, made and entered into between the Welfare and Educational Institutions Employers Association (employer party), of the one part, and the Zimbabwe Educational, Scientific Social and Cultural Workers' Union (employee party), of the other part, being parties to the National Employment Council for the Welfare and Educational Institutions, shall be read as one with the agreement published in Statutory Instrument 102 of 2014 (hereinafter referred to as "the principal agreement").

1. The principal agreement is amended by the repeal of section 31 and the substitution of —

"Resolution of industry disputes

- 31. (1) A designated agent appointed in terms of the Act may— $\,$
 - (a) require any employer for which the Council is registered—
 - to grant him or her reasonable access to his or her employees for the purpose of advising

and assisting them in relation to their rights of employment;

- (ii) to grant him or her reasonable access to his or her premises and to the books, records and other documents relating to his or her employment for the purpose of examining and ascertaining matters relating to or affecting the employment of his or her employees who are represented by a trade union or federation of trade unions which a member of the council, and of ascertaining whether or not the terms of any relevant Collective Bargaining Agreement and regulations are being followed;
- (b) enter any premises of an employer for which the Council is registered for the purposes of conducting any search therein, where there are reasonable grounds for believing that such entry or search is necessary for the prevention, investigation or detection of an offence in terms of the Act or this agreement or for the seizure of any property which is the subject of an offence in terms of the Act or this agreement.

(2)-

 (a) any dispute or unfair labour practice which constitutes a dispute of right shall be determined by the designated agent after hearing the parties concerned:

Provided that where the parties agree to such a course, the designated agent may determine the matter on written submissions filed by both parties without conducting an oral hearing;

(b) for the avoidance of doubt, where a party to the dispute requests for an oral hearing, it shall be improper for the designated agent to determine the matter on papers. (3) The determination by the designated agent shall be communicated to the parties in writing.

(4)—

- (a) in respect of a dispute of interest, the designated agent shall attempt to resolve or redress the dispute through conciliation first and where a Certificate of No Settlement is issued, Part XII of the Act shall apply;
- (b) where a Certificate of Settlement is issued, it shall have the same effect as a determination made in terms of subsection 2.
- (5) Where the designated agent discovers a breach of right through his or her inspection of workplaces, he or she may issue an order directing the defaulting party to take corrective action. The order shall clearly indicate the defaulting party and the person or persons affected by the breach.
- (6) The order issued in terms of subsection (5) shall provide for the rectification of the breach by the defaulting party within a period specified in the order.
- (7) In determining the period within which the defaulting party is to rectify the breach, the designated agent shall take into consideration and shall be guided by the following factors—
 - (a) the nature of the breach;
 - (b) the urgency of the matter;
 - (c) the attitude of the defaulting party; or
 - (d) whether or not the breach poses an imminent danger to the health or safety of any person or persons concerned at the workplace.
- (8) An order made by the designated agent shall have the same effect as a determination made in terms of subsection (2).
- (9) Any party aggrieved by the determination or order made by the designated agent may appeal to the Labour Court in terms of the Act and the Labour Court Rules.

Collective Bargaining Agreement: Welfare and Educational Institutions (Dispute Resolution)

- (10) A designated agent shall keep a proper record or summary of proceedings or decisions taken in terms of this section which record or summary shall be made at the time such proceedings and decisions are taken. The record shall contain at least the following—
 - (a) the names of the parties;
 - (b) the names of their lawyers (if any);
 - (c) a statement of the claim or alleged breach;
 - (d) a statement of the relief sought;
 - (e) a summary of any other issues between the parties as agreed by them;
 - the names of the witnesses and a summary of their evidence;
 - (g) a record of questions and answers in cross-examination and re-examination;
 - (h) a record of documentary or other exhibits produced; and
 - (i) a judgment, that is, a conclusion on the evidence, accompanied by an explanation of how and why that conclusion was reached, which witnesses were disbelieved and which provisions of the law were found to be applicable.
- (11) A designated agent shall keep a record of proceedings of each case for a period of twelve (12) months from the date the decision is made.
- (12) A party to whom a settlement, decision, order or determination relates may submit for registration the copy of it furnished to him or her by the designated agent to the Court of any magistrate which would have had jurisdiction to make the order had the matter been determined by it, or, if the decision, order or determination exceeds the jurisdiction of any Magistrates Court, the High Court.

- (13) Where a settlement, decision, order or determination has been registered in terms of subsection 10 it shall have the effect, for purposes of enforcement, of a civil judgment of the appropriate court.".
- 2. The principal agreement is amended by the insertion after section 32 of the following sections—

"Dispute settlement

- 32A. (1)Where the parties to a dispute before a designated agent settle the dispute on their own, the designated agent shall require the parties to furnish him or her with a written agreement disposing of the dispute.
- (2) Upon receipt of the agreement referred to in subsection (1), the designated agent shall issue a consent determination and serve each party with a copy of the determination.
- (3) Where the agreement by the parties in dispute partially settles the dispute(s) between the parties, the designated agent shall issue a consent determination covering the agreed issue(s) and deal with the balance of issues as contested, and such contested issues shall in that event be in all subsequent respects action for such contested issues only.

Code of ethics

- 32B. (1) It shall be the duty of every designated agent to act in such a manner as to ensure that
 - (a) impartiality and principles of natural justice are observed at all times;
 - (b) he or she discloses to the parties any current or past managerial, representational, or consultative relationship with any employer or employers' organisation, trade union or a federation that is involved in the dispute at hand;
 - (c) all pre-hearing matters are handled in a manner that fosters complete impartiality;

Collective Bargaining Agreement: Welfare and Educational Institutions (Dispute Resolution)

- (d) a fair and adequate hearing which assures that both parties have sufficient opportunity to present their case is held and that where written submissions are made, to ensure that these are exchanged between the parties and that each party is given a reasonable opportunity to make counter submissions;
- (e) the hearing process is conducted so as to advance the fair and efficient resolution of the matter(s) submitted for decision, including making all reasonable efforts to prevent delaying tactics, harassment of parties or other participants or other abuse or disruptions being practiced;
- (f) he or she discharges duties with propriety without being influenced by—
 - (i) any partisan interest, or public clamour;
 - (ii) family, personal, social, political or other interests.
- (2) Upon reaching a decision on the matter at hand, it is not proper for a designated agent to inform anyone of any decision in advance of the time it is given to all parties.

Representation of parties

- 32C. (1) Subject to the provisions of the Act, a party to a matter before a designated agent may be represented by—
 - (a) a fellow employee; or
 - (b) an official of a registered trade union or employer's organisation; or
 - (c) a legal practitioner".

Customs and Excise (Tariff) (Amendment) Notice, 2021 (No. 27)

IT is hereby notified that the Minister of Finance and Economic Development has, in terms of section 225 of the Customs and Excise Act [Chapter 23.02], made the following notice:—

- 1.(1) This notice may be cited as the Customs and Excise (Tariff) (Amendment) Notice, 2021 (No. 27).
- (2) This notice shall be deemed to have come into effect on 1st January, 2020.

Income Tax (Rate of Interest) Notice, 2021

THE Minister of Finance and Economic Development, in terms of sections 48, 71 and 73 of the Income Tax Act [Chapter 23:06], hereby makes the following notice:—

Title

 This notice may be cited as the Income Tax (Rate of Interest) Notice, 2021.

Rate of interest on unpaid or overpaid income tax in foreign currency

- 2. (1) Subject to subsection (2), the rate of interest for any month or part thereof during which tax remains unpaid shall, for the purposes of sections 48, 71 or paragraph 3(1) of the Thirteenth Schedule of the Act, be ten *per centum* with effect from 1st January, 2020.
- (2) The Commissioner-General shall pay interest at the rate referred to in subsection (1) on any amount of refund due in terms of section 48 which has not been refunded by him or her within thirty days after the date of receipt of a tax return:

Provided that where the non-payment of the refund was due to the submission of an incomplete or defective return, which the Commissioner-General brought to the attention of the taxpayer within the thirty days, the thirty-day period shall commence to run afresh from the date of resubmission of the correct or complete return.

3. The Income Tax (Rate of Interest) Notice, 2021, published in Statutory Instrument 55 of 2021, is repealed.

Finance (Rate of Incidence of Intermediated Money Transfer Tax) Regulations, 2021

IT is hereby notified that the Minister of Finance and Economic Development has, in terms of section 3 of the Finance Act [Chapter 23:04], made the following regulations:—

Title

1. These regulations may be cited as the Finance (Rate of Incidence of Intermediated Money Transfer Tax) Regulations, 2021.

Amendment of Thirtieth Schedule to Cap. 23:06

- 2. The Thirtieth Schedule ("Intermediated Money Transfer Tax") to the Income Tax Act [Chapter 23:06] is amended in paragraph 1 ("Interpretation")(1) in the definition of transaction on which the tax is payable by the insertion of the following paragraph after paragraph (aa)—
 - "(bb) transfers from Designated Special Purpose Accounts created for the delivery of projects by Implementing Partners of organisations covered under the Privileges and Immunities Act [Chapter 3:03].".
