#### Honours and Awards (Amendment) Notice, 2022 (No. 1)

IT is hereby notified that His Excellency, the President of Zimbabwe and Commander in Chief of the Defence Forces of Zimbabwe has, in terms of section 3(4) of the Honours and Awards Act [Chapter 10:11], made the following notice:—

- 1. This notice may be cited as the Honours and Awards (Amendment of Warrant) Notice, 2022 (No. 1).
- 2. The Warrant 1 of 2021, published in Statutory Instrument 213 of 2021, is amended as follows—
  - (a) in section 1 by the insertion of the word "Agriculture" between "... Commendation Award for ..." and "... Community Development" and wherever it appears in the definition of "Joshua Mqabuko Nyongolo Nkomo Commendation Award for Community Development, Peace Building and Fostering Unity";
  - (b) in section 2 by the insertion of a new paragraph before paragraph (a)—
    - "(a1) the Order of the Great Zimbabwe Diamond;";
  - (c) by the insertion of the following subparagraphs after section 3(a)—
    - "(i) of a maximum diameter of 179.98 millimetres;
    - (ii) the diamond being of a maximum of 5.5 millimetres:".
