POLITICAL PARTIES (FINANCE) ACT [CHAPTER 2:11]

Disbursement of Money to Registered Political Parties

IT is hereby notified, in terms of section 3(2) of the Political Parties (Finance)Act [*Chapter 2:11*], that the total amount of moneys payable to political parties in respect of the year beginning 1st January, 2023, and ending on the 31st December, 2023, is one billion five hundred million dollars only.

The money shall be disbursed to political parties that qualify in terms of section 3(3) of the Act as follows:

- (a) one billion, fifty million four hundred and fifty thousand dollars (\$ 1 050 450 000,00), shall be paid to the Zimbabwe African National Union (Patriotic Front) ZANU (PF) which received 70.03% of the votes cast; and
- (b) four hundred and forty-nine million five hundred and fifty thousand dollars (\$449 550 000,00), shall be paid to the Movement for Democratic Change-Alliance-(MDC-A), which received 29.97% of the total votes cast.
