- (4) Where any matter is added after the copy has been prepared, and such additional matter results in one or more sheets being inserted between those already numbered, all sheets must be renumbered from there onwards—not, for instance 7, 7b, 8, et cetera.
- 4. Photographic copy or copy produced on a duplicating machine may be accepted if it is abundantly clear.
 - 5. (1) Should any copy-
 - exceed 10 pages of double-spaced typing on size A4 paper; or
 - (b) contain tabular or other matter which involves complicated setting; it will be classed as "lengthy" copy, and will be required to be submitted not less than 21 days before the date of closing for the Gazette in which it is to be published.
- (2) Lengthy copy may be accepted at less than 21 days' notice if—
 - (a) the work involved is of a straight forward and non-tabular nature; and
 - (b) the total volume of work on hand for the time being permits its acceptance.
- Notwithstanding anything to the contrary contained in these conditions, any copy—
 - (a) which is of national importance, and which is originated as a matter of urgent necessity, may, by prior arrangement, be accepted late for the current week:
 - (b) may, due to shortage of staff or to technical considerations, be delayed until conditions permit its processing.
- 7. Copy must not be submitted as part of a letter or a requisition. It must appear on a separate sheet of paper, on which there is no instruction or other extraneous matter.
- 8.(1) In cases where notices have to be published in tabular form, copy must be drafted exactly as it is to appear. If printed forms for any such notices are unavailable, advertisers must prepare their

own forms. While it is not necessary to include the preamble, the box-headings must be there, and, where applicable, the number of the form; for example, "Insolvency Regulations—Form 3".

- (2) In the case of copy for tabular notices, the provision of subsection (2) of section 3 does not apply.
- Copy for all advertisements, whether sent by post or delivered by hand, must be accompanied by a requisition or a letter which clearly sets out—
 - (a) the name and address of the advertiser; and
 - (b) the debtor's code number, if any; and
 - (c) the required date or dates of publication.
- 10. If a typographical error occurs in the *Gazette*, it is rectified as soon as possible by a correcting notice without charge to the ministry or department concerned, subject to the following conditions—
 - (a) that such error is reported to the editor within three months from the date of publication; and
 - (b) that the relevant copy, upon re-examination, is proved to be abundantly clear; and
 - (c) that the correction of such error is legally necessary.
- (2) If a drafting error is not detected before publication, the originating ministry or department is required to draft its own correcting notice, take it to the Attorney-General for vetting and pay for such notice to be published.
 - (3) For the removal of doubt—
 - (a) a typographical error is made by a typographer;
 - (b) a typist's error is classed as a drafting error by reason of the fact that the officer responsible for drafting failed to check the typist's work.

City of Bulawayo (Clamping and Tow-away) By-laws, 2023

IT is hereby notified that the Minister of Local Government and Public Works, in terms of section 229 of the Urban Councils Act [Chapter 29:15], has approved the following by-laws:—

Title

1. These by-laws may be cited as the City of Bulawayo (Clamping and Tow-away) By-laws, 2023.

Interpretation

- In these by-laws—
 - "authorised person" means any person employed or delegated by council to carry out any function in terms of these by-laws;
 - "central business district" means the area bounded by Masotsha Ndlovu Avenue, 15th Avenue, Lobengula Street and Samuel Parirenyatwa Street;
 - "Council" means City of Bulawayo;
 - "Council controlled area" means any area within the jurisdiction of City of Bulawayo;
 - "motor vehicle or vehicle" means any motor vehicle or vehicle as defined in the Road Traffic Act [Chapter 13:11];
 - "owner" means any person in whose name a motor vehicle is registered, including any person duly authorised by the registered owner to have possession and control of the motor vehicle and to whom documentary proof of the ownership has been vested;
 - "secure compound" means any area designated by council for the purpose of safekeeping of vehicles and motorvehicles removed under these by-laws;
 - "tow-away" means the removal by an authorised person of a motor vehicle or vehicle that will have violated these by-laws to a secure a compound;
 - "wheel clamp" means a device used to immobilise a motor vehicle or vehicle parked or stationary in contravention of these by-laws.

Application

These by-laws shall apply to the area under the jurisdiction of the City of Bulawayo.

Wheel clamping and tow away

- 4. (1) Any authorised person may, if he or she has reason to believe that a violation of traffic by-laws referred to in the Schedule has been committed—
 - immobilise or cause such vehicle to be immobilised by way of a wheel clamp; and
 - (b) if the motor vehicle has not been clamped and the relevant charges incidental thereto paid, subsequently remove and tow away the motor vehicle to a secure compound after a period of at least two hours has elapsed:

Provided that a motor vehicle shall be clamped simultaneously with the issuance of a traffic ticket for the violation of the by-laws;

and

- in the case of either a co-operating or first time offender, an authorised person may escort the offender to a secure compound with the owner or driver of the offending vehicle driving. An authorised person, provided is licensed according to the Road Traffic Act [Chapter 13:11], may drive an impounded vehicle to the storage compound at a cost equivalent to that of tow fees. Any accident, harm or injury to both the authorised person and impounded vehicle or motor vehicle shall be the responsibility of the owner of the vehicle together with medical expenses that may occur thereto and the car might be sold by council at an auction in case the offender fails to take such a responsibility. Any person or driver who drives or takes an escorting detail to a place other than storage yard shall be liable to charges of kidnapping or any other charge in terms of the criminal laws.
- (2) Not withstanding subsection (1), where the motor vehicle is obstructing traffic, an authorised person may not clamp the vehicle

first but shall immediately remove and tow away the motor vehicle to a secure compound.

- (3) Risk in any motor vehicle removed to a secured compound in terms of these by-laws shall remain with the owner.
- (4) A motor vehicle removed to a secure compound shall be released upon payment by the owner of such motor vehicle—
 - (a) a specified penalty; and
 - (b) wheel clamping, tow away and storage charges specified in the Schedule.

Unclaimed vehicles

- 5. (1) Council shall publish in any newspaper circulating within the council area list of vehicles immobilised and advise the owners to claim the vehicles within a period of thirty (30) days.
- (2) Council shall sell by public action any vehicle that remains unclaimed thirty (30) days after a notice has been published.
- (3) Council shall deduct charges specified in the Schedule from the proceeds of the sale of the motor vehicle and any balance shall be paid to the owner upon written request within thirty (30) days from the date that such request is submitted.
- (4) Council shall operate a special account into which money realised from the sale of unclaimed vehicles shall be deposited.
- (5) Any money not claimed within one year after the sale of the motor vehicle shall be forfeited to Council.
- (6) Payment of the prescribed penalty, tow away and storage fees shall be made to council financial services department, a revenue hall or to any of the authorised person who shall issue a miscellaneous receipt together with the duplicate of the ticket as proof of payment.

Designation

- 6. Council shall publish in any newspaper circulating within the Council controlled area
 - (a) any place designated as a secure compound; and

(b) the names of any persons appointed as an authorised persons.

Cifences

- 7. (1) Any person who—
 - (a) unlawfully attempts to obstruct, obstructs, or causes to be obstructed, any person in the exercise of his or her duties under these by-laws; or
 - (b) unlawfully attempts to remove, removes or causes to be removed a wheel clamp; or
- (c) unlawfully attempts to remove, removes or causes to be removed a motor vehicle from a secure compound; shall be guilty of an offence and liable to a fine not exceeding level 3 or to imprisonment for a period not exceeding one year or to both such fine and imprisonment.
- (2) Abandoned vehicles or motor vehicles and trailers will be given a ten (10) days' notice to be removed, failing which council shall tow them to a secure compound at a cost to the owner.
- (3) Abandoned motor vehicle shells and wracks, those with punctured tyres, parked in council bays or any council land unlicensed in terms of the Road Traffic Act [Chapter 13:11] shall be regarded as dirt and nuisance and removed immediately to a secure compound without notification at a cost to the owner.
- (4) Vehicles or motor vehicles in a dirty and filthy state not displaying valid licence discs will be immediately removed from the road or any area under the jurisdiction of the at a cost to the owner.
- (5) Push carts shall not be allowed in the part of the central business area bounded by Nelson Kutshwekhaya (N.K.) Ndlovu Avenue, Lobengula Street, Joseph Msika Avenue and R. Mugabe Way, any violation will attract a level 1 fine plus impounding costs.

Indemnity

8. (1) Council shall be indemnified against any damages that may occur in the opening by authorised persons of motor vehicles that

will be subjected to towing and any vehicle or motor vehicle whose owner or driver fail to pay before close of business shall be towed to a secure compound with or without owner's consent.

(2) Vehicles that load passengers from undesignated areas, those that do not meet Road Motor Transportation Act [Chapter 13:15], Public Service vehicle requirements and those engaged in piracy whether locally or foreign registered, may after clearing fines with council be handed over to the government vehicle engineering department, the police, Zimbabwe Revenue Authority or any other government arm of the law for inspection and clearance.

Repeal

 The Bulawayo City Council (Clamping and Tow-away) Bylaws, 2015, published in Statutory Instrument 63 of 2015, are hereby repealed.
